### WELCOME ADDRESS BY UNDERSECRETARY FOR FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION OF ITALY MS. MARIA TRIPODI

### ANNUAL MEETING OF THE ASSEMBLY OF PARTIES 30 NOVEMBER 2022

Mr. President, Ambassador Bruno Archi, Madam Director General, Jan Beagle, Members of the Diplomatic Corps accredited to Rome, Ladies and Gentlemen,

It is a great pleasure for me to open the IDLO Assembly of Parties and to welcome you to Rome and to the Farnesina, after another difficult year for all of us.

The challenges of our time are many, complex and interconnected.

The aftermath of the Covid-19 pandemic and the war in Ukraine, added to the effects of climate change, have fueled multidimensional crises, making it increasingly difficult to achieve the Sustainable Development Goals globally.

We know that sustainable development can only be achieved in peacetime. The international community as a whole should therefore be fully committed to the principles of international law and a rules-based order.

The rule of law plays a key role in sustaining peace by helping to address the root causes of conflict and insecurity. In addition, a just and inclusive society based on the rule of law enables poor, marginalized and other vulnerable groups to access essential public services such as justice, health and education.

The protection and promotion of human rights and fundamental freedoms and the fight against all forms of discrimination have always been at the heart of Italy's policy and action, both nationally and internationally. Italy firmly believes that stronger institutions, enabling more effective governance, can reduce inequality while promoting sustainable development, which in turn is an enabling factor for peace, justice and inclusion.

IDLO's role is of the utmost importance, especially given that its mandate - upholding the rule of law and promoting justice as a mean to sustainable development - is unique

among international organizations and multilateral bodies. And we are aware that even in this area, strengthening multilateral cooperation is the only way to overcome crises.

Italy fully supports IDLO and its activities. IDLO's growing visibility consolidates the Organization's international relevance in the implementation of the 2030 Agenda and in particular Sustainable Development Goal 16: to promote peaceful and inclusive societies for sustainable development, provide access to justice for all, and build effective, accountable and inclusive institutions at all levels. I would like to mention in this regard that in the last four years Italy has organized a global conference on Sustainable Development Goal 16 in Rome, with an exceptional level of participation. We hope to organize the next edition in the spring.

We also appreciate the strengthening of partnerships that IDLO has built in recent years with the United Nations development system, both in Rome and New York. In the same spirit, we support IDLO's efforts in its programs to promote justice for women and girls, to support access to justice despite continuing restrictions on mobility, and to improve efficiency and transparency in the administration of justice in partner countries.

Under pandemic COVID 19, IDLO in collaboration with WHO led an effort to strengthen legal and policy frameworks on pandemic preparedness and public health emergency response. In collaboration with FAO, it developed projects to mitigate the impact of emergency laws and regulations on food supply, particularly with regard to marginalized and vulnerable groups.

### Ladies and gentlemen,

In recent years we have worked intensively with IDLO and have witnessed the gradual acquisition of relevance of the Organization in the framework of international organizations headquartered in Italy. I am confident that the collaboration will be increasingly fruitful and productive of results.

Mr./Mdm. Chairperson,

Distinguished Delegates,

Pour la région du Sahel et plus particulièrement le Burkina Faso, l'OIDD a lancé, le 28 mai 2021, le programme d'«Appui intégré aux systèmes de justice pénale au Sahel». Le Burkina Faso se félicite de l'état d'exécution de ce programme avec notamment la mise en place de deux nouveaux Cadres de Concertation (CdC) des acteurs des chaines pénales de Ouagadougou et de Bobo-Dioulasso, en plus de ceux existants. Ces CdC sont des structures efficaces, améliorent le travail au sein des juridictions et la communication entre les acteurs, et renforcent la confiance des justiciables.

Le format des CdC tel qu'il existe est approprié, simple, à moindre coût de sorte que les CdC sont durables même lorsque l'appui de l'OIDD prendra fin.

Les résultats sont d'ailleurs déjà perceptibles et les acteurs de terrain nous font parvenir des motifs de satisfaction pour le professionnalisme, l'écoute et le respect mutuel des acteurs par les équipes terrain de l'OIDD.

Ces résultats sont d'autant plus appréciés par le Gouvernement du Burkina Faso qu'ils interviennent dans un contexte de crise au Sahel, ou de nombreux partenaires, pour des raisons de sécurité, ont suspendu ou arrêté leur projets et programmes d'appui dans les zones sous influence terroriste. L'OIDD est toujours présente.

L'appui à l'accès à la justice par la franche vulnérable de la population, notamment les femmes et les jeunes filles, évoqué dans le rapport se matérialise dans mon pays par un soutien de l'OIDD au Fonds d'Assistance Judiciaire, organisme qui prend en charge, au profit des personnes vulnérables, les frais générés par les procédures judiciaires. C'est

# STATEMENT OF ECUADOR ANNUAL MEETING OF THE ASSEMBLY OF PARTIES 30 NOVEMBER 2022

### Señora Directora General y distinguidas autoridades presentes:

Agradezco tanto a IDLO como al Ministerio de Asuntos Exteriores de Italia, por la organización de este evento, y agradecemos el magnífico reporte presentado por la Directora General, así como los valiosos documentos que han sido puestos en consideración de los Estados miembros.

Como habíamos expresado en ocasiones anteriores, mi país considera al Estado de Derecho como una norma de convivencia que establece las condiciones para un desarrollo sostenible en beneficio de la humanidad.

El Gobierno de Ecuador está empeñado en fortalecer la institucionalidad del país, particularmente en las áreas vinculadas con la administración de justicia.

Para este efecto se ha organizado una consulta popular que permitirá a la ciudadanía ecuatoriana manifestarse democráticamente para adoptar determinadas reformas que cuyo objetivo es reforzar el Estado Derecho y mejorar los niveles de seguridad para nuestros compatriotas.

La corrupción es un enemigo que no conoce fronteras y destruye la convivencia pacífica de las sociedades, impide el desarrollo de los países y provoca desconfianza en las instituciones, por tal motivo, la lucha contra la corrupción se ha convertido en un objetivo prioritario del Gobierno del Ecuador.

Mi país enfrenta un terrible desafío por la amenaza del crimen transnacional organizado y el narcotráfico, cuyos tentáculos quieren desestabilizar el sistema de administración de justicia. Estamos luchando contra esta amenaza, que no tiene fronteras, pero requerimos del apoyo de la comunidad internacional para combatirla.

Junto a los Gobiernos de Países Bajos y de Canadá, Ecuador esta co-organizando la Mesa Redonda de Alto Nivel sobre Anticorrupción, que se realizara en La Haya, entre el 28 y 29 de noviembre de 2022.

La Mesa Redonda antes mencionada surge luego de la cumbre sobre Democracia y Corrupción celebrada el 8 de diciembre de 2021 y constituye una iniciativa de los Gobiernos de Canadá, Países bajos y Ecuador, con el objetivo de formar una mesa de trabajo de Alto Nivel, para tratar el tema de la corrupción internacional desde una perspectiva multidimensional.

Los tres países han venido trabajando para generar documentos de discusión y recomendaciones de política pública que recojan su visión en torno a tres temas cruciales en materia de la lucha internacional contra la corrupción: marco jurídico vigente, brechas y soluciones, y voluntad política.

En el marco de la Mesa Redonda de Alto Nivel en La Haya, se espera suscribir una Declaración Ministerial de Principios, para cuyo efecto se están realizando sendas representaciones ante las cancillerías de los países invitados.

Es muy grato para nosotros informar que la Embajada de Ecuador en Italia, planteó al Comité Organizador, conformado por representantes de Países Bajos, Canadá y Ecuador, la posibilidad de invitar al IDLO para intervenir en este importante evento, y esa sugerencia ha sido aceptada. IDLO será uno de los ponentes en la Mesa Redonda.

Entre el 22 y el 23 de noviembre del presente año tendrá lugar en Ecuador la Segunda fase del Programa Falcone-Borsellino, iniciativa del Gobierno Italiano para brindar asistencia internacional en materia de combate a la corrupción y al crimen organizado.

Mi país agradece la cooperación que recibimos del Gobierno de Italia, especialmente la Diplomacia Judicial, y valoramos la posibilidad de trabajar juntos en el combate a enemigos que no conocen fronteras.

Coincidimos plenamente con la preocupación de la Director General sobre la grave amenaza que representa el cambio climático y, ante ello, reafirmamos que un enfoque adecuado para hacer frente a esta amenaza es el principio de responsabilidades comunes pero diferenciadas, en las que los principales contaminadores asumen el costo. para detener el cambio climático.

Consideramos indispensable la necesidad de mantener un adecuado balance entre el desarrollo económico, la protección del ambiente, y una mejor calidad de vida para la sociedad.

La noción de justicia climática debe contribuir a producir normas adecuadas para reconocer las responsabilidades que le competen a cada país, y que no son las mismas para todos.

# STATEMENT OF KENYA ANNUAL MEETING OF THE ASSEMBLY OF PARTIES 30 NOVEMBER 2022

### Ladies and Gentlemen.

- 1. Thank you very much for this opportunity to deliver this statement on behalf of Kenya delegation to the annual Assembly of State parties to the IDLO.
- 2. The Kenya delegation note with appreciation the elaborate report presented by the Director-General on the activities and programmes of IDLO over the last one year, particularly the tangible outcomes in the backdrop of global challenges such as prolonged Covid-19 pandemic, climate change which has impacted negatively on economic growth world over.
- 3. We also applaud the DG and her team for addressing these critical emerging challenges confronting humanity today through innovative programmes focusing on inclusive economic development, climate justice, food security and healthy lives and well-being for all.
- 4. The successful outcomes of this programmes presented in the report are clear testament of the DG able stewardship of the organization during this difficult period and times in the world.

- 5. Allow me to make some comments with deep gratitude in respect to IDLO's activities and programmes in promoting the rule of law to advance peace and sustainable development in Kenya as follows;
  - i. IDLO provided technical support to the Kenya Judiciary Academy to establish an e-learning platform which enabled Judicial officers to benefit from online training programmes that would otherwise have been inaccessible because of Covid-19 pandemic.
  - ii. To deal with backlogged of civil cases in the Judiciary. Kenya established small claims courts which hear civil cases with awards or damages totaling maximum 8,200 euros or Kshs 1million.
  - iii. IDLO supported training for newly appointed adjudicators and informational workshops about the purpose and workings of the new courts.

- iv. In addition, IDLO facilitated the development of guidelines for the costs of proceedings, and contracted clerks to enter data of all cases onto a new web portal.
- v. In the efforts of reversing the epidemic of chronic Non-Communicable Diseases (NCDs) in pursuit of promoting healthy lives and well-being and in partnership with World Health Organization and International Development Research Centre.
- vi. Kenya is among Bangladesh, Tanzania, Uganda and Sri Lanka in the IDLO pilot social mobilization programme in the Global Regulatory and fiscal capacity building programme (RECAP). IDLO is working with civil society in each of these pilot countries to build an enabling environment for legislation and policy reforms to prevent NCDs.
- 6. We in Kenya welcome the fruitful partnerships IDLO has been building with our Independent Criminal Justice institutions in order for them dispense just, fair and swift judgements which are prerequisite for sustainable peace, development and prosperity of our country.
- 7. In conclusion, we once again commend IDLO for the success full outcomes of its programmes in different member Parties in line with its new strategic plan 2021-2024 given the current difficult and challenging global environment.
- 8. Let us all remain committed in supporting IDLO aspirations and mandate of promoting the rule of law in our collective endeavor of advancing peace, justice and sustainable development in Member Parties and beyond.
- 9. I thank you all for your attention.

We think the Strategic Plan captures this challenge and provides a roadmap for IDLO to develop and grow as an organization. We will follow these reforms initiatives with interest.

The Netherlands also recognizes IDLO's ambition to expand the scope of its strategic engagement, focusing on the role of the rule of law for strengthening economic development, climate justice, sustainable use of land and natural resources, and public health. IDLO rightfully chooses to invest in these merging areas of work, as these embody challenges that are expected to become more evident, prominent and accentuated in the years to come. We are expectant of IDLO making valuable policy and programming contributions on these areas during the current Strategic Plan cycle.

Lastly, The Netherlands actively supports IDLO programming both at Headquarters and in the field, where we work with IDLO in numerous countries, such as Mali, Burkina Faso, Niger, Somalia, Tunisia, Uganda, Kenya and Afghanistan.

We look forward to continuing and deepening our partnership.

# STATEMENT OF SWEDEN ANNUAL MEETING OF THE ASSEMBLY OF PARTIES 30 NOVEMBER 2022

### Thank you, Madam President.

First of all, let me extend a sincere and warm thank you to the Director General and all her staff for the comprehensive report presented here today.

We are most grateful to IDLO for the relentless work that your organisation does for the common challenges that we face for the rule of law.

Russia's unprovoked, full-scale invasion of Ukraine earlier this year, shows that IDLO's work to promote accountability and the rule of law has never been more critical since the establishment of the organisation in 1983. IDLO's support to the Office of the Prosecutor General in Ukraine stands as one but yet strong example of IDLO's relevance and importance in this difficult time for Europe and the world.

Human rights including gender equality, democracy and the rule of law continue to be top priorities for the new Swedish government and all areas of Sweden's foreign policy. A human rights-based approach is the internationally agreed modus operandi including in the area of rule of law and access to justice, whether we call it people-centred justice or not. As development partners, it is therefore crucial to address the capacity gaps of both rights holders and duty bearers to deliver on the development effectiveness agenda and to achieve sustainable development results.

Sweden, as one of the main supporters and donors of IDLO, has always underlined the capacity building of national legal institutions as one of the primary pillars of IDLO's work. Whether it may be its partnership with the Supreme Court of Justice in Honduras, or its support to the establishment of a Specialized Anti-Corruption Court in Armenia, this is where IDLO adds real value to its member states. To the rule of law.

Ladies and gentlemen, let me remind you that the strengthening of the rule of law in all our countries is not just the right thing to do. It's what we *must* do. It's what we are *obliged* to do according to international human rights law.

That is also why Sweden takes the partnership with IDLO beyond its traditional formats. Today, Sweden and IDLO collaborate on a number of events and initiatives – several of them reflecting our common priorities on the environment, gender equality and much more. IDLO's participation in the Stockholm +50 summit earlier this year is one of many such examples.

Sweden will put further emphasis on human rights, democracy and the rule of law in the coming months, as part of our EU presidency during the first six months of 2023. Together with like-minded countries and partners such as IDLO Sweden will continue to

emphasise that the rule of law is crucial for the realization of Agenda 2030, particularly SDG16.

Looking at a more operational priority going forward, we would also like to encourage the IDLO to widen its donor base. Because let us be frank, even if the budget for the IDLO will be growing by 16% in 2023, it is not sustainable to leave an organisation of IDLO's magnitude and importance into the hands and dependability of only a handful of donor states.

Not only IDLO plays a key role here, but even more so all of you, its member states. Sweden is, as one of IDLO's main donors, more than willing to share our excellent experiences from a donor's perspective. For any member state considering to further expand its support to the IDLO, our door is always open.

We hope that in the coming year, States and organisations together can keep the momentum and truly anchor a rule of law-based approach as part of multilateral and bilateral cooperation. The conversations we are having here today is one important step.

### **Distinguished Participants**,

On behalf of my government, it is a great pleasure for Uganda to participate at today's Assembly as a member of this organization. Uganda's decision to join this organization was informed by IDLO's objectives of the promotion of peace, justice and sustainable development.

On the onset, we would like to extend our gratitude and appreciation to IDLO for the wonderful work they are doing in Uganda particularly in the Justice Law and Order Sector (JLOS). IDLO's intervention of enhancing capacity of our justice actors has gone a long way to improve our law and justice system right from the grassroots through to district and up to the national level.

IDLO's continued support to both state and non-state legal aid, legal empowerment and other justice delivery mediations has exposed our justice actors to modern aspects of exercising their duties, for instance in adopting the use of information and technology within the justice institutions, criminal justice reforms, strengthening forensic investigation, prosecution and adjudication of crimes, expanded state funded legal aid services, enhanced commercial and land justice sector reforms which was a topic of discussion in the conference held in Kampala recently sponsored by IDLO. This is also in tandem with the climate justice related interventions by IDLO.

This capacity improvement by IDLO has given the Ugandan justice actors the confidence with which to provide the citizens with quality legal knowledge, aid and redress. This has had a positive effect on the access to quality justice by all especially for the poor, vulnerable and the marginalized in the rural areas and even urban centres specifically to women and girls. The community justice program being carried out by IDLO came in handy during the covid 19 pandemic whereby these vulnerable groups were able to access medication as well, thus improving the people's trust in the justice system instead of taking the law into their hands. In fact, public trust in the JLOS stands at 59%. While the police stand at 67%. (Chief Justice Report, 2020).

The JLOS objectives is to build a pro-people justice delivery system of better quality service and customer in which customer care is emphasized; infusing of human rights approach to their work and full enforcement of Bill of Rights; and, their strategic objective

is to contribute to economic growth and development informed by the country's Vision 2040 of transforming Uganda to a middle income country therefore, enhancing private sector development is critical in this aspect and hence the need to create a justice system that would respond to the needs of the private sector. JLOS continues to work under the guidance of 3Cs: - Cooperation, Coordination and Communication, which comes handing in their partnership with IDLO.

Allow me to mention a few outcomes from among several justice interventions that IDLO continues to make to our JILOS. For instance, they have provided support to the legal-aid services, including mediations, legal representation, advice and referral services, to a total of 10,040 people including 5,241 women and girls in more than 15 districts.

Recently, IDLO championed matters related to climate law, including land reform, laws encompassing nutrition, food access and security, health laws and access to medicines and gender equality and many other interventions some of which are long term. I cannot exhaust all the good work IDLO has done and continues to do in Uganda in a few minutes.

As we continue to applaud the work IDLO and partners in Uganda, we still need IDLO's intervention in the matters of enhancement of the capacity of other sectors of the economy while we look forward to continue working with then law and justice actors so that all our citizens particularly the vulnerable, the poor and the marginalized including women, girls and children can access quality, equitable and sustainable justice so that all citizens live in dignity and equality under the rule of law.
