How can WGRI 5 / SBSTTA 18 delegates participate?

CBD Party delegates are invited to join the IDLO, CBD Secretariat and partners in panel and small group "knowledge exchange" sessions, aimed at fostering debate on the key challenges and opportunities for biodiversity laws. Countries with promising experiences with laws for biodiversity will share their experiences in an opening plenary session. Then all country delegates will be invited to share experiences in two "knowledge exchange" sessions, first in regional groupings and second, in groups for each of the 5 Strategic Goals. All delegates are invited to attend, in particular, we welcome interventions from countries on:

Guiding Questions for Country Interventions

- What are the main challenges and obstacles that your country has faced in implementing laws to meet national biodiversity goals?
- Are laws and institutions key for achieving the broad goals across the Strategic Plan for Biodiversity 2011-2020? If so, what legal approaches exist to achieve Strategic Goals A, B, C, D, and E respectively?
- Has your country had a promising experience with using law to achieve national biodiversity goals, in particular to mainstream and implement NBSAPs?
- Is there a recent development or progress achieved related to laws for biodiversity in your country, i.e. a new law passed, new mechanisms established, or new success story?

Interventions from countries can range from full panel presentations to informal statements/case studies to guide thinking during the small group sessions. Delegates who wish to simply attend without a formalized interventions are also welcome. Participants are encouraged to speak openly about the challenges and emerging successes with laws in their country, and collaboratively seek new legal solutions with fellow participants. This open discussion will greatly inform the following work on ideas to move forward.

What knowledge and expertise will be available to inform the Roundtable?

The Dialogue discussions will be informed by the legal research undertaken since 2012 under the *Legal Preparedness for Achieving the Aichi Biodiversity Targets Initiative*, launched by the IDLO and CBD Secretariat. The Initiative provides a hub for global collaborations to generate knowledge and build capacities on the role of law in achieving key biodiversity goals. Participants will gain access to country case studies and new toolkits on how to use law to achieve the Aichi Targets and Nagoya Protocol. Global experts from IDLO, IUCN, UNEP, the Fridtjof Nansen Institute, Centre for International Sustainable Development Law, BENELEX, Natural Justice and others will present the latest tools and guidance available to assist CBD Parties in panel presentations and Knowledge Sharefair.

Topics to be covered in Expert Presentations and at Knowledge Sharefair

- NBSAPs implementation and biodiversity mainstreaming (IDLO, UNEP, FNI)
- Nagoya Protocol (IDLO, CISDL, ABS Initiative
- Protected areas and integrated planning (IUCN)
- Benefit-sharing, human rights and corporate accountability (BENELEX)
- ICCAs and Community Protocols (Natural Justice)
- Biodiversity incentives and ecosystem approaches (IDLO, FNI)

Mr. Braulio Ferreira de Souza will host a Roundtable discussion at the event with all participants invited to join the discussion to discuss the emerging challenges, innovations and priorities for furthering the discussion on laws for biodiversity leading to the CBD COP 12 and beyond.
