ANNEX A INSTRUCTIONS TO BIDDERS

1.	General Considerations	In preparing the Proposal, the Bidder is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal. The Bidder will not be permitted to take advantage of any errors or omissions in the RFP. Should such errors or omissions be discovered, the Bidder must notify IDLO.
2.	Cost of the Proposal	The Bidder shall bear all costs associated with the preparation and submission of the Proposal. IDLO will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the solicitation.
3.	Currency of Proposals	Proposals shall be nominated exclusively in USD . Note: Local Bidders/Suppliers must comply with any applicable laws regarding doing business in other currencies
4.	Language of the Proposal	The Proposal and all correspondence and documents relating to the Proposal exchanged by the Bidder and IDLO shall be written in the English language.
5.	Delivery Term and Place	Services are to be provided to: IDLO Kabul, Afghanistan Country Office and Beneficiary Institution. Bidder to advise IDLO if their proposal has elements of supply of goods. If yes, Bidder must inform if Customs Clearance are required and whose responsibility it is to do so
6.	Deadline for Submissions of Proposals	The Proposal shall be addressed to IDLO on or before Date: January 7, 2021 Time: 15:00 Hours Rome, Italy local time. Note: Proposals submitted by email must be limited to a maximum of 10MB, virus-free and no more than two email transmissions. They must be free from any form of virus or corrupted contents, or the quotations shall be rejected.
7.	Documents comprising the Bidder's Proposal	 The Proposal shall comprise the following components: 1. Proposal Submission Form (see Annex D); 2. Bidder Information Form (see Annex E) 3. Bidder's Proposal divided into: a. Technical Proposal (see Annex F1) b. Financial Proposal /Price Schedule (see Annex F2)
8.	Contents of solicitation documents	Proposals must offer services for the total requirement, unless specified otherwise in this RFP.



	Proposals offering only part of the requirement will be rejected.
	The Bidder is expected to examine all corresponding instructions, forms, terms and specifications contained in the Solicitation Documents. Failure to comply with these documents will be at the Bidder's risk and will affect the evaluation of the Proposal.
9. Clarification of solicitation documents	A prospective Bidder requiring any clarification on this RFP may contact IDLO by email on <u>tenders@idlo.int</u> no later than 72 hours prior to the deadline for submission of Proposals.
	The requests for clarification will have " Request for clarifications for RFP No. N_235_2020_AFG] " mentioned in the subject.
	Written copies of the organization's response (including an explanation of the query but without identifying the source of inquiry) will be sent to all prospective Bidders that have received the Solicitation Documents or posted on IDLO website.
	Any delay in IDLO's response shall not be used as a reason for extending the deadline for submission, unless IDLO determines that such an extension is necessary and communicates a new deadline to all the Bidders.
10. Amendments of solicitation documents	At any time prior to the deadline for submission of Proposals IDLO may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Solicitation Documents by amendment.
	All prospective Bidders that have received the Solicitation Documents will be notified in writing of all amendments to the Solicitation Documents.
	In order to afford prospective Bidders reasonable time for taking the amendments into account and preparing their offers, the procuring IDLO entity may, at its discretion, extend the deadline for the submission of Proposals.
11. Proposal submission	The Bidder shall structure the Technical part of the Proposal as follows:
	(a) Proposed methodology This section should demonstrate the Bidder's responsiveness to the TOR/specifications by identifying the specific components proposed, addressing the requirements, as specified, point by point; providing a detailed description of the essential performance characteristics, proposed warranty and demonstrating how the proposed methodology meets or exceeds the requirements.



	The Technical part of the Proposal should not contain any pricing information whatsoever on the services offered. Pricing information shall be separated and only contained in the appropriate Price Schedules. Any technical proposal containing price information will be disqualified from consideration.
	It is mandatory that the Bidder's Proposal numbering system corresponds with the numbering system used in the body of this RFP. All references to descriptive material and brochures should be included in the appropriate response paragraph, though material/documents themselves may be provided as annexes to the Proposal/response.
	Information which the Bidder considers proprietary, if any, should be clearly marked "proprietary" next to the relevant part of the text and it will then be treated as such accordingly.
12. Format, signing sealing, marking and submission of Proposals	The Proposal shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to the contract. The latter authorization shall be indicated by written power-of-attorney accompanying the Proposal.
	The Proposal must be submitted using the format specifically detailed in Annex D, E and F.
	A Proposal shall contain no interlineations, erasures, or overwriting except, as necessary to correct errors made by the Bidder, in which case such corrections shall be initialled by the person or persons signing the Proposal.
	The Proposal will consist of two attached files named "Technical Proposal" and "Financial Proposal".
	The "Financial Proposal " file will contain Price Schedule (see Annex F2) and will be password-protected by the Bidder. If the proposal passed the Technical Evaluation, IDLO will additionally communicate with Bidders for obtaining the password for Financial Proposal. Only Financial Proposals from Bidders whose Technical Proposals have passed the Technical Evaluation will be opened.
	The Bidder shall send two emails; one for Technical Proposal and one for the Financial Proposal to <u>tenders@idlo.int</u> with the Subject: "Technical Proposal for RFP No. N_235_2020_AFG"
	and with the Subject: "Price Proposal for RFP No. N_235_2020_AFG



	before the deadline stipulated in this RFP.
13. Joint Venture, Consortium, or Association	If the Bidder is a group of legal entities that will form or have formed Joint Venture (JV), Consortium or Association for the Proposal, they sha confirm in their Proposal that : (i) they have designated one party to a as a lead entity, duly vested with authority to legally bind the member of the JV, Consortium or Association jointly and severally, which shall be evidenced by a duly notarized Agreement among the legal entities, an submitted with the Proposal; and (ii) if they are awarded the contract the contract shall be entered into, by and between IDLO and the designated lead entity, who shall be acting for and on behalf of all the member entities comprising the joint venture.
	After the Deadline for Submission of Proposal, the lead entity identifier to represent the JV, Consortium or Association shall not be altered without the prior written consent of IDLO.
	The lead entity and the member entities of the JV, Consortium Association shall abide by the requirement outlined in the following section in respect of submitting only one proposal.
	The description of the organization of the IV, Consortium or Association must clearly define the expected role of each of the entity in the join venture in delivering the requirements of the RFP, both in the Propose and the JV, Consortium or Association Agreement. All entities the comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by IDLO.
	 A JV, Consortium or Association in presenting its track record an experience should clearly differentiate between: a) Those that were undertaken together by the JV, Consortium Association; and b) Those that were undertaken by the individual entities of the J Consortium or Association.
	Previous contracts completed by individual experts working privately b who are permanently or were temporarily associated with any of th member firms cannot be claimed as the experience of the JV, Consortiu or Association or those of its members, but should only be claimed the individual experts themselves in their presentation of their individu credentials.
	JV, Consortium or Associations are encouraged for high value, mult sectoral requirements when the spectrum of expertise and resource required may not be available within one firm.



	The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entity in the joint venture in delivering the requirements of the RFP, both in the Proposal and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by IDLO.
14. Only One Proposal	 The Bidder (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture. Proposals submitted by two (2) or more Bidders shall all be rejected if they are found to have any of the following: a) they have at least one controlling partner, director or shareholder in common; or b) any one of them receive or have received any direct or indirect subsidy from the other/s; or c) they have at relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the Proposal of, another Bidder regarding this RFP process; e) they are subcontractors to each other's Proposal, or a subcontractor to one Proposal also submits another Proposal under its name as lead Bidder; f) or some key personnel proposed to be in the team of one Bidder participates in more than one Proposal received for this RFP process. This condition relating to the personnel, does not apply to subcontractors being included in more than one Proposal.
15. Late Proposals	Any Proposal received by IDLO after the deadline for submission of Proposals, pursuant to clause <i>Deadline for the submission of Proposals</i> , will be rejected and sent back unopened or destroyed unopened if the return cannot be secured unless the Proposal was sent by email but was not properly received due to issues in IDLO mailing system.
16. Validity Period of Proposals	All Proposals will be valid for 90 days from the deadline for submission of Proposals. In exceptional circumstances IDLO may request the Bidders to extend the validity of the Proposal beyond what has been initially indicated in this RFP. The Bidders shall be invited to confirm the extension in writing, without any modification whatsoever on the Proposal. The Bidders may choose not to extend the validity period of the Proposals upon request of IDLO.
17. Modification and withdrawal of Proposals	The Bidder may modify/withdraw its Proposal after the Proposal's submission, provided that written notice of the withdrawal is received by IDLO prior to the deadline prescribed for submission of Proposals.



18. Amendment of the proposal	The Bidder's modification/withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of clause Deadline for Submission of Proposals. No Proposal may be modified nor withdrawn after to the deadline for submission of Proposals. No Proposal may be modified/withdrawn in the Interval between the deadline for submission of Proposals and the expiration of the period of Proposal validity specified by the Bidder in the Proposal Submission Form. At any time prior to the deadline of Proposal submission, IDLO may for any reason, such as in response to a clarification requested by a Bidder, modify the RFP in the form of an amendment to the RFP. Amendments will be made available to all prospective bidders.
	If the amendment is substantial, IDLO may extend the Deadline for submission of proposal to give the Bidders reasonable time to incorporate the amendment into their Proposals.

20. Right to accept, reject, or render non- responsive any or all Proposals	IDLO reserves the right to accept or reject any Proposal, to render any or all of the Proposals as non-responsive, and to annul the solicitation process and to reject all Proposals at any time prior to award of contract, without incurring any liability, or obligation to inform the affected Proposer(s) of the grounds for IDLO's action. Furthermore, IDLO shall not be obliged to award the contract to the lowest priced offer.
21. Clarification of Proposals	To assist in the examination, evaluation and comparison of Proposals, IDLO may at its discretion ask the Bidder for clarification of its Proposal. The request for clarification and the response shall be in writing and no change in price or substance of the Proposal shall be sought, offered or permitted.
22. Evaluation of Eligibility and Qualification	 In general terms, Bidders that meet the following criteria may be considered qualified: a) They are not included in IDLO Sanctions lists (EU, US, UN); b) They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments, c) They have the necessary similar experience, technical expertise, production capacity where applicable, quality certifications, quality assurance procedures and other resources applicable to the provision of the services required; d) They are able to comply fully with IDLO General Terms and



	 Conditions of Contract; e) They do not have a consistent history of court/arbitral award decisions against the Bidder; and f) They have a record of timely and satisfactory performance with their clients.
23. Price variation	Bidders shall not vary their prices for any reason after the deadline of the tender and while the Proposal is still valid.
24. Preliminary Screening	IDLO will screen the Proposals' Annex D and E to determine whether they are complete, whether the documents have been properly signed, and whether the Proposals are generally in order. Only Bidders that pass will proceed to Technical Evaluation
25. Correction of errors	In the event of a discrepancy between the unit price and the total price, the unit price shall prevail and the total price shall be corrected by IDLO. If the Bidder does not accept the final price based on IDLO's correction of errors, its Proposal will be rejected.
26. Due Diligence	 IDLO reserves the right to undertake a due diligence exercise aimed at determining to its satisfaction, the validity of the information provided by the Bidder. Such exercise shall be fully documented and may include, but need not be limited to, all or any combination of the following: a) Verification of accuracy, correctness and authenticity of information provided by the Bidder; b) Validation of extent of compliance to the RFP requirements and evaluation criteria based on what has so far been found by the evaluation team; c) Inquiry and reference checking with Government entities with jurisdiction on the Bidder, or with previous clients, or any other entity that may have done business with the Bidder; d) Inquiry and reference checking with previous clients on the performance on on-going or contracts completed, including physical inspections of previous works, as necessary; e) Physical inspection of the Bidder's offices, branches or other places where business transpires, with or without notice to the Bidder; f) Other means that IDLO may deem appropriate, at any stage within the selection process, prior to awarding the contract.



27. Responsiveness of Proposals	IDLO will determine the substantial responsiveness of each Proposal to the RFP. For purposes of this Clause, a substantially responsive Proposal is the one which materially conforms to the requirement of the tender and any mandatory terms contained in the Solicitation Documents.
	IDLO's determination of a Proposal's responsiveness is based on the contents of the Proposal itself without recourse to extrinsic evidence.
28. Evaluation of Proposal	A two-stage procedure is utilised in evaluating the Proposals after Preliminary Screening has been conducted; with evaluation of the Technical Proposal being completed prior to Financial Proposal being opened and compared.
	The Financial Proposals (Price Schedules) of the overall Proposals will be opened only for submissions that passed minimum technical score of 490 points of the maximum obtainable 700 points.
	The evaluation will be conducted in accordance with the cumulative analysis method, according to which the Technical and Financial Proposals have pre-assigned weights and pre-assigned maximum number of scores:
	 Technical Proposal -70%, - 700 points maximum, Financial Proposal - 30%, - 300 points maximum.
	The contract will be awarded to the Proposal with highest combined score obtained in technical and financial evaluation.
	Technical Evaluation The technical Proposal is evaluated on the basis of its responsiveness to the Terms of Reference (TOR) as per the evaluation criteria below. The obtainable number of points specified for each evaluation criterion indicates the relative significance or weight of the item in the overall evaluation process.
	Financial Evaluation In the second stage the Financial Proposals of all Bidders who attained a minimum 490 points in Technical Evaluation will be reviewed. The lowest amount for technically qualified Financial Proposal will be awarded maximum 300 points and other Financial Proposals will be awarded points in accordance with the following formula: Financial Proposal score = (Lowest Price / Price under consideration) x 300.
29. Debriefing	In the event that a Bidder is unsuccessful, the Bidder may request a debriefing from IDLO. The purpose of the debriefing is to discuss the



	strengths and weaknesses of the Bidder's submission, in order to assist the Bidder in improving its future proposals for IDLO procurement opportunities. The content of other proposals and how they compare to the Bidder's submission will not be discussed.
30. Right to Vary Requirements at the time of the Award	 □ N/A for Framework Agreement ☑ Yes - At the time of award of Contract, IDLO reserves the right to vary (increase or decrease) the quantity of Services by up to a maximum twenty-five per cent (25%) of the total offer, without any change in the unit price or other terms and conditions.
31. Contract Signature	Within five (5) calendar days from the date of receipt of the Contract, the successful Bidder shall sign and date the Contract and return it to IDLO. Failure to do so may constitute sufficient grounds for the annulment of the award, and forfeiture of the Proposal Security, if any, and on which event, IDLO may award the Contract to the Second Ranked Bidder or call for new Proposals.
32. Payment Terms	IDLO will make payment within 30 days after satisfactory receipt of all goods and upon submission of the invoice by the Supplier.
33. General Terms and Conditions and Supplier Code of Conduct	Any Contract or Purchase Order that will be signed as a result of this RFP shall be subject to the IDLO's General Terms and Conditions and Supplier Code of Conduct attached as Annex H. The mere act of submission of a Proposal implies that the Bidder accepts both Annexes in full.
34. Liquidated Damages	 N/A ☑ Yes - For late delivery of Goods, IDLO shall be entitled to claim liquidated damages from the Contractor in accordance with Article 23 of the General Terms and Conditions. Liquidated damages for inferior quality or non-conformance of specifications of Goods will be assessed on a case-by-case basis in accordance with the severity of the problem as determined solely by IDLO. The application of this liquidated damages provision shall not relieve the Contractor of its obligations or liabilities pursuant to this Contract.

ANNEX C TERMS OF REFERENCE Management Information System Assessment

A. About IDLO

The International Development Law Organization (IDLO) is an intergovernmental organization exclusively devoted to promoting the rule of law. Established in 1983, IDLO works to enable governments and empower people to reform laws and strengthen institutions to promote peace, justice, sustainable development and economic opportunity. Its programs, research and policy advocacy cover the spectrum of rule of law from peace and institution building to social development and economic recovery in countries emerging from conflict and striving towards democracy.

The Assembly of Parties is IDLO's highest decision-making body. It is composed of Representatives of all Member Parties, which have joined the Establishment Agreement of IDLO. IDLO currently has 37 Member Parties.

IDLO has its Headquarters in Rome, a Branch Office in The Hague, Liaison Offices for the United Nations in New York and Geneva, and Country Offices in Afghanistan, Armenia, the Bahamas, Burkina Faso, Honduras, Indonesia, Kenya, Kyrgyzstan, Jordan, Liberia, Mali, Mexico, Moldova, Mongolia, Myanmar, Niger, the Philippines, Somalia, Tunisia, Uganda and Ukraine.

The work of IDLO is sustained by a dynamic, diverse, multinational and multicultural workforce, comprised of over 400 employees plus additional personnel in the non-employee category such as consultants and interns. About one fourth of the IDLO workforce is based in its Headquarters in Rome, while the rest are spread across the globe in our Branch and Country offices.

B. Background

For nearly two decades, IDLO has been assisting the Government of the Islamic Republic of Afghanistan (GIROA) in the development of accessible, accountable, effective, and efficient justice sector institutions. While significant progress has been made, many challenges remain. Some of these challenges are perceived to be rooted in the ongoing conflict, the impact of insecurity, and the public's fear for their safety. In its 2017 National Justice and Judicial Reform Plan, the GIROA identified ongoing conflict and insecurity as the main reason for a "rift between citizens and justice and judicial entities." Research also indicates that security concerns continue to impede women's professional participation in Afghanistan's justice sector, with very few specific strategies in place to address this challenge.

IDLO Afghanistan is implementing a project that aims to assess the current status of the justice sector's inclusiveness and accessibility, study the impact of insecurity and implement interventions that can ameliorate this impact. Under the Reducing the Impact of Insecurity on Afghanistan's Legal System (RIIALS) program, IDLO aims to work with the Government of the Islamic Republic of Afghanistan to alleviate the challenges to the justice sector caused by insecurity. Under the RIIALS program, IDLO will design interventions that will build on its



existing efforts to assist Afghanistan's justice institutions to increase access to justice, expand professional capacity and achieve greater professional gender parity. These interventions will include providing partner institutions with assistance to improve their policies and procedures and to pilot interventions in line with their strategic plans. These efforts will be designed to ensure that justice workers and those they serve can feel safer and thereby: 1) expand access to justice sector professionals; and 3) advance women's meaningful participation in the justice sector. The RIIALS project is in line with the National Justice and Judicial Reform Plan, which recognizes the importance of safety and security for the justice sector to function effectively.

As a part of the RIIALS program, IDLO will be supporting its institutional partner to assess its need for a Management Information System (MIS) that can facilitate information sharing between justice sector actors, institutions and consumers. IDLO seeks to engage a Service Provider who will be able to provide recommendations on the feasibility of using existing government systems, the availability of other existing systems that can be purchased, or specific features that must be included in a customized design. If a MIS is not advisable, the Service Provider will be required to provide recommendations as to how best to utilize the institutions existing infrastructure to improve their information sharing.

C. Expected Output

IDLO is looking to engage a Service Provider to assess the feasibility of utilizing an electronic Management Information System at the office of an IDLO institutional partner to generate reports related to performance of justice sector actors and others who report to this partner. This system should support the management of this institution to develop policies and make decisions about the allocation of resources, staff, etc.

The outputs for this project will be:

- Consultations with institutional partner staff and other justice sector stakeholders to understand key activities and deliverables, and how those would be complemented by an electronic MIS;
- 2. A thorough assessment of any existing MIS and/or management control system at the institution.
- 3. An assessment of the current IT system and its ability to support an MIS including a review of the physical infrastructure (physical layout, and space allocation within the beneficiary institution office, and features that would allow such a system to be cost-effective, comprehensive, and sustainable);
- 4. A detailed report containing a recommendation on the feasibility and potential design of an MIS system, including:
 - a. A detailed list of the hardware and software specifications for the MIS along with an estimation for projected maintenance, software and hardware upgrades; and,
 - b. A detailed list of key staff that would require training on the use and maintenance of a MIS.
- 5. Submission of an assessment report based on consultations and equipment review.



6. Presentation of findings to IDLO and institutional partner.

D. Institutional Arrangement

This assignment will be based in Kabul, Afghanistan at the offices of the beneficiary institution. The successful Supplier will be required to provide weekly reports to the RIIALS Field Program Manager outlining progress and noting any challenges encountered.

IDLO will liaise with the partner institution to ensure that the Service Provider has access to institutional data and staff.

E. Duration of the Work

The Work is expected to be completed within 45 calendar days from Contract signature of both Parties.

F. Work Location

The location will be based in Kabul, Afghanistan at the offices of the institutional partner.
