PROCEEDINGS MEETING OF THE ASSEMBLY OF PARTIES November 24, 2020

- 1. The 2020 Annual Meeting of the Assembly of Parties (the Assembly) of the International Development Law Organization (IDLO), was held on 24 November 2020 in virtual modality, due to restrictions related to the ongoing global COVID-19 pandemic.
- 2. Thirty-five IDLO Member Parties attended the meeting, a large majority at the Ambassadorial level.

AGENDA ITEM 1: OPENING

- 4. The President of the Assembly, Ms. Jennifer Harhigh, Deputy Permanent Representative of the United States Mission to the United Nations Agencies in Rome, welcomed Member Party representatives and other participants.
- 5. She recalled with appreciation the gracious hospitality that the Italian Ministry of Foreign Affairs and International Cooperation had extended in previous years to the Assembly, while noting that current circumstances had necessitated holding this year's meeting online.
- 6. The President gave the floor to H.E. Emanuela Del Re, Italian Vice Minister of Foreign Affairs and International Cooperation, to deliver the opening statement.

AGENDA ITEM 1A: STATEMENT BY H.E. EMANUELA DEL RE, VICE MINISTER FOR FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION OF ITALY

- 7. The Vice Minister began by highlighting the essential contribution that the rule of law makes to combating the effects of the COVID-19 pandemic, by supporting the capacity of public institutions to provide transparent, effective, and accountable policies and actions.
- 8. Citing a recent intervention by IDLO's Director-General in the Foreign Affairs Committee of the Italian Chamber of Deputies, she stated: "the rule of law can play a key role in sustaining peace by helping to address the root causes of conflict and insecurity, which often lie in issues such as discrimination and marginalization, lack of respect for human rights, corruption and impunity."
- 9. Recalling IDLO's unique mandate among international organizations and multilateral bodies, she observed that its actions were increasingly important



- in the current context, adding that Italy was advocating for increased investments in the rule of law and access to justice sectors.
- 10. She continued by outlining Italy's main priorities during its current membership on the Human Rights Council, noting that the protection of human rights and fundamental freedoms is enshrined in the Italian Constitution.
- 11. She also referred to Italy's key role in the fight against corruption, including in the context of the upcoming Italian Presidency of the G20 and highlighted that the Ministry had invited IDLO to participate in the work of the G20 Anti-corruption Working Group.
- 12. Underlining the importance that Italy places on its collaboration with IDLO, she informed the Assembly that a special invitation had been extended to the Director-General to address the forthcoming session of the Development Cooperation Joint Steering Committee.
- 13. She further referred to the candidature of Mr. Stefano Manservisi, presented by Italy for IDLO's Board of Advisers, noting how his extensive experience would increase IDLO's international relevance and the quality of its activities.
- 14. She also especially welcomed IDLO's growing partnerships within the UN system, and its increased collaboration with FAO in the area of food security and with WHO on pandemic preparedness.
- 15. The Vice Minister concluded by reiterating Italy's strong political and financial support for IDLO and called on other Members to join Italy in committing to support the Organization in delivering on its mandate to achieve sustainable development. - 16. The President thanked the Vice Minister for her inspiring opening remarks.

AGENDA ITEM 1B: ADOPTION OF THE AGENDA (AP/2020/1.1)

- 17. Before turning to this agenda item, the President called attention to a number of housekeeping rules for the conduct of the meeting in its virtual modality.
- 18. The President then referred to the provisional agenda (AP/2020/1.1) which had been circulated to Member Parties on 3 November 2020. Absent any comments by Member Parties, the agenda was adopted by consensus.

AGENDA ITEM 1C: PRESIDENT'S STATEMENT

19. The President began by saying that the United States was proud to have supported IDLO as President of the Assembly for the past three years, which she described as an extremely productive period for the Organization. During this time, she said, IDLO had welcomed new Member Parties, opened new field offices, signed Host Country Agreements, and elected and successfully transitioned to a highly effective new Director-General.

- 20. She commended IDLO for responding so capably through high-quality programs to the growing demand for its services and for its impressive achievements, in spite of the constraints brought about by the pandemic.
- 21. She remarked on how IDLO's successes and the Director-General's interventions in international fora were helping to elevate the rule of law in global policy discussions.
- 22. The President went on to express her thanks to the other members of the bureau of the Assembly Mozambique and Italy for their leadership and advocacy in support of the Organization, and to all the other members of the Standing Committee and the Audit and Finance Committee for their contributions. She underlined the importance of the work of these committees in ensuring Member Parties' input to, and oversight of, IDLO operations and encouraged all members to participate actively in the governance of the organization by joining one of these committees in the years ahead.
- 23. The President conveyed the support of the United States for the ambitious performance targets laid out in IDLO's new Strategic Plan, Management Plan and Budget. Noting how the COVID-19 pandemic had highlighted existing inequalities, she stressed that any sustainable recovery would have to be founded on justice and the rule of law. She concluded by underscoring the importance of the Assembly's role in helping to set IDLO, a "one-of-a-kind intergovernmental organization," on the right path to make the greatest possible impact in the years ahead.
- 24. She then gave the floor to the Director-General to present her report.

AGENDA ITEM 2: DIRECTOR-GENERAL'S REPORT (AP/2020/2.1)

- 25. The Director-General began by thanking Vice Minister Del Re for her opening remarks and for her strong commitment to IDLO. She also thanked the President for her leadership, the Vice-Presidents and all the members of the Standing Committee and the Audit and Finance Committee for their ongoing support during her first year in office. She also paid tribute to IDLO's staff around the world for their hard work and resilience during what had been an incredibly challenging year, noting that none of IDLO's achievements would have been possible without the commitment and dedication of its staff.
- 26. The Director-General stressed how the ongoing pandemic had aggravated global fragilities and inequalities and was threatening to reverse hard-won advances towards the achievement of the 2030 Agenda.
- 27. She underlined the crucial importance of a rule of law-based response in managing the crisis and laying the foundations for a just, inclusive and sustainable post-COVID-19 recovery.
- 28. She reported that IDLO's work during 2020 had focused on three key objectives: ensuring mission continuity while protecting the health and wellbeing of staff; contributing to the global response to the pandemic, and to the

- Decade of Action to accelerate implementation of the 2030 Agenda; and developing a forward-looking Strategic Plan for the next four years.
- 29. The Director-General outlined some of the key measures adopted by IDLO at the onset of the COVID-19 crisis, including the establishment of a Crisis Management Team, the development of Business Continuity Plans for all IDLO offices, and the establishment of a hotline available to all staff. As the situation evolved, each IDLO office had developed "return to office" plans, taking into account local contexts and guidance from host governments. She emphasized that, throughout, the situation in all IDLO duty stations was being monitored closely and plans remained flexible to allow for adjustments as needed. She commended IDLO staff for their resilience and ability to adapt working modalities, which enabled IDLO to continue delivering on its mandate in some of the most complex and challenging environments in the world.
- 30. Despite restrictions affecting almost all countries of operation, IDLO had responded quickly to the emerging needs of its program countries, leveraging programmatic and policy expertise and drawing on its ability to mobilize multi-stakeholder coalitions.
- 31. She went on to describe the three strategic areas on which IDLO focused its contribution to the global response to COVID-19, namely:
 - promoting enabling legal and policy frameworks;
 - mitigating the impact of the crisis on justice systems and justice seekers;
 - advocating for continued investment in a culture of justice.
- 32. The Director-General drew attention to the launch of IDLO's Policy Brief on "Rule of Law and COVID-19", which identifies eight specific actions to support policymakers in mitigating the impact of the pandemic.
- 33. She also referenced two recent innovative projects: the first, developed in collaboration with FAO, which aims to enhance food security, especially for vulnerable groups, and will be piloted in Honduras and Uganda; and a second, developed in collaboration with the World Health Organization, which focuses on pandemic preparedness and response, and aims to support countries to strengthen their legal and policy frameworks to manage public health emergencies such as COVID-19. In the same context, the Director-General referred to IDLO's participation—together with WHO, UNDP, UNAIDS, IPU and the O'Neill Institute of National and Global Health Law—in the "COVID-19 Law Lab"; and to IDLO's involvement in discussions on the legal aspects of equitable access to future COVID-19 vaccines in low- and middle-income countries.
- 34. The Director-General further reported on developments in IDLO's work on "inclusive economic development," citing examples from a range of countries where IDLO supported the strengthening of legal capacity to address pressing economic issues in the context of COVID-19, such as insolvency, antitrust, public procurement and dispute resolution.

- 35. She also highlighted progress in the implementation of IDLO's Investment Support Programme (ISP/LDCs) which provides legal advice and capacity-building support to Least Developed Countries on investment-related matters at no cost to beneficiaries, citing a recent achievement in The Gambia where IDLO assisted the government in negotiating a favorable settlement in an international arbitration case related to off-shore petroleum licensing.
- 36. Turning to the second focus area mitigating the impact of the crisis on justice seekers the Director-General provided examples of activities in the area of customary and informal justice as well as illustrations of IDLO's work to promote access to justice for vulnerable groups, combat gender-based violence, and support justice institutions to deliver essential services.
- 37. She cited examples of access to justice programming in several countries, including Afghanistan, Honduras, Liberia, Myanmar and Uganda. In Uganda, following signature of a Host Country Agreement, IDLO had begun implementing a Community Justice Programme to help increase grassroots access to legal aid, information, and justice services, including through digital platforms.
- 38. On the subject of gender-based violence (GBV), the Director-General cited examples from Mongolia, Somalia and Tunisia, where IDLO had managed to adapt its programming to respond to the increased demand for support during the pandemic by enhancing the gender sensitivity of justice institutions to GBV response and recovery; supporting survivors in seeking legal redress; and promoting legal and policy frameworks to counter and prevent GBV.
- 39. The Director-General reported on IDLO's engagement with justice institutions in many countries, including Afghanistan, Indonesia, Kenya, Kyrgyzstan, Mexico, the Philippines, Rwanda and Yemen, in order to support them in carrying out key functions remotely through the development and use of ejustice tools and mechanisms. She noted that IDLO had recently received the inaugural USAID Digital Project Award in recognition for its work in Kyrgyzstan.
- 40. She reported on the successful 2020 launch of a major new program in the Sahel to strengthen criminal justice chains in the border areas of Mali, Burkina Faso and Niger.
- 41. On the subject of informal and customary justice, she provided a number of examples of IDLO programming in Kenya, Uganda, the Sahel and Somalia.
- 42. Moving to the third area of focus advocating for continued investment and support for the rule of law the Director-General observed that financial support for the rule of law, despite a growing recognition of its importance in achieving global development goals, had declined in recent years, and that the global pandemic was likely to exacerbate this trend.

- 43. She went on to describe IDLO advocacy efforts during 2020 through online dialogues, webinars and other platforms, collaborative initiatives with multistakeholder coalitions and the production of a number of key research and knowledge products. She referred in the same context to her own participation in high-level intergovernmental meetings, including the 75th session of the UN General Assembly and associated events and the High-Level Segment of the 43rd Human Rights Council.
- 44. She also mentioned the successful launch on 1 July of IDLO's Crisis Governance Forum, a series of online dialogues on governance challenges related to COVID-19 which provide a platform to share insights and good practices among policymakers and other key stakeholders.
- 45. Pointing to justice for women and girls as an area of special emphasis in IDLO's advocacy work, she called attention to a key publication launched during the year on "Justice for Women Amidst COVID-19", developed in partnership with UN Women, UNDP, UNODC, the World Bank, Pathfinders and The Elders, which provides an assessment of challenges and recommendations on how to mitigate the disproportionate impact of the pandemic on women and girls.
- 46. On the overall issue of partnerships, the Director-General highlighted the importance she places on expanding their scope and reach, and as a crucial way of enhancing IDLO's convening power, leveraging its impact, and positioning the Organization as a leading change agent in the field of rule of law and access to justice.
- 47. In this context she noted that, prior to restrictions imposed by the pandemic, she had been able to meet with key stakeholders in Rome, The Hague, Geneva and New York, and with the heads of most of IDLO's United Nations partners. These included the executive heads of UN Women, UNDP, UNICEF and UNFPA, as well as the heads of UN political and peacebuilding, peacekeeping, humanitarian and development departments within the United Nations.
- 48. The Director-General also reiterated in this regard her commitment to further strengthening IDLO's collaboration with Rome-based organizations, including FAO, IFAD, WFP and UNIDROIT. She further underlined the importance of enhancing collaboration with regional organizations and reported that, along with pursuing a strategic partnership with the EU, IDLO was developing plans to strengthen cooperation with the African Union and ASEAN, among others.
- 49. Referring to IDLO's global network of alumni as a significant source of expertise and support, the Director-General indicated that she had prioritized outreach to them, including through the launch of a new newsletter, "Alumni Voices."
- 50. She added that the consultation process for IDLO's Strategic Plan 2021-2024 had provided an excellent opportunity to connect with IDLO's many partners.

- 51. Turning to management issues, the Director-General highlighted a range of digital innovations that had been introduced to strengthen internal communication and integration and improve operational capacity and staff development. She referred in this context to the introduction of periodic Town Hall meetings with the participation of IDLO staff in all locations. She also described how upgrading core ICT services to cloud-based platforms had allowed IDLO staff to use online services and maintain operations during long periods of teleworking, as well as facilitating online professional development through webinars and a new e-learning platform.
- 52. Finally, on the subject of finances, the Director-General noted that IDLO had started 2020 in a sound financial position with healthy reserves and an Operational Fund, which gave it confidence to navigate a fast-changing financial environment. She highlighted IDLO's achievement of International Public Sector Accounting Standards (IPSAS) within its financial structures, including producing for the first time IPSAS-compliant financial statements for 2019. She was pleased to report that the Organization was on track to meet its revenue targets for 2020, as budgeted. She also highlighted IDLO's conservative yet flexible approach to the development of a balanced Operational Budget for 2021.
- 53. The Director-General concluded by citing the UN Secretary-General on the importance of inclusive multilateralism in building societies that are more just, peaceful and inclusive, and reaffirming IDLO's belief that the rule of law is the surest means to build such societies.¹

GENERAL DEBATE

- 54. The President thanked the Director-General for her comprehensive and inspiring report, noting how much had happened since the Assembly's last meeting in November 2019 and commenting on how remarkable IDLO's recent achievements were under the leadership of the new Director-General.
- 55. She then opened the General Debate, inviting Member Parties to take the floor.
 - The Assembly heard interventions by the representatives of Afghanistan, Burkina Faso, China, Ecuador, Egypt, France, Italy, Kenya, Liberia, Mali, Mozambique, the Netherlands, Pakistan, Peru, the Philippines, Senegal, Sudan, Sweden, Turkey, Uganda, the United States and Vietnam.
- 56. The full text of all statements delivered and subsequently shared with the IDLO Secretariat are annexed to this report and available online at this link.
- 57. In their interventions, Member Parties voiced their shared appreciation to the Director-General for her report and for IDLO's achievements during her first year in office, in spite of the challenging circumstances resulting from the pandemic.

- 58. Representatives shared IDLO's conviction that the rule of law is central to managing the COVID-19 crisis and to promoting resilience against future shocks.
- 59. They also highlighted IDLO's unique mandate and its leadership role in promoting the rule of law and advancing its contribution to achieving the goals of the 2030 Agenda.
- 60. Representatives of States where IDLO is currently operating expressed appreciation for IDLO's work in their respective countries. IDLO's new program in the Sahel received particular attention in a number of interventions. The representatives of Burkina Faso and Mali welcomed the launch of the program in support of the region's criminal justice chains, and the representative of France stated that his country was keen to explore heightened cooperation with IDLO in the Sahel, where France has a strong presence.
- 61. The Director-General thanked the Ambassadors and other representatives for the kind words addressed to her and to IDLO's staff, and for their support for IDLO's mandate and their commitment to multilateralism. She concluded by expressing the hope that people-centered justice would become the "new normal."

AGENDA ITEM 3: STRATEGIC PLAN 2021-2024, MANAGEMENT PLAN 2021-2022 AND OPERATING BUDGET 2021 (AP/2020/3.1, AP/2020/3.3 and AP/2020/3.4)

- 62. The President introduced the agenda item by drawing attention to the background documents: the draft Strategic Plan 2021-2024 (AP/2020/3.1), draft Management Plan 2021-2022 (AP/2020/3.3) and the draft Operating Budget for 2021 (AP/2020/3.4).
- 63. She noted that the draft Strategic Plan 2021-2024 had been reviewed and endorsed by the Standing Committee at its meeting on October 19 for onward transmission to the Assembly of Parties; the draft Operating Budget for 2021 had been carefully reviewed by the Audit and Finance Committee and recommended for approval by the Standing Committee; and the draft Operating Budget and the draft Management Plan 2021-2022 had been subsequently reviewed and approved by the Standing Committee, also at its October 19 meeting.
- 64. The President further noted that all documents had been circulated to Member Parties in advance of the meeting, and then gave the floor to the Director-General to present the documents.
- 65. The Director-General began by remarking that she would address some of the issues raised by Member Parties during the General Debate as part of her current presentation.
- 66. Referring first to the draft Strategic Plan 2021-2024, the Director-General recalled that the Plan had been developed during a period characterized by

great disruption and in a fast-changing global environment. IDLO had approached the task with the intent of turning challenges into opportunities, balancing prudence with ambition and building on the organization's established strengths, while at the same time investing in new areas where it has the ability to make a distinct contribution.

- 67. The Plan's overall objectives, she said, were to set out IDLO's overall strategic direction for the next four years; define IDLO's contribution to global efforts to sustain peace and development, in line with its mandate and comparative advantages; and identify areas where IDLO needs to invest to strengthen the overall contribution of the Organization.
- 68. At the same time, she continued, IDLO had developed for the first time a twoyear Management Plan geared to implement the first half of the new Strategic Plan. The Management Plan sought to present a diverse and well-balanced portfolio of programs, research, and advocacy activities to maximize IDLO's contribution to peacebuilding and sustainable development, and, in that context, to the global response to COVID-19. It also set out the priority reforms identified under the Strategic Plan that will be initiated in the next two years to support IDLO in achieving the results envisaged in the Management Plan.
- 69. The 2021 Operating Budget, she added, would implement the first year of the Plan, balancing caution with ambition within a rapidly evolving environment.
- 70. The Director-General noted that the consultations undertaken in connection with the elaboration of the Strategic Plan had been the broadest ever for IDLO and had included some 90 in-person interviews; 20 focus group consultations with stakeholders in Rome, Geneva, New York, The Hague, as well as in IDLO country offices; and a wide circulation of online surveys.
- 71. By listening to IDLO's partners and conducting a review of the previous Plan, IDLO had identified achievements as well as key challenges faced during the previous cycle and the resulting lessons to be learned.
- 72. Commenting on the key trends that had emerged from the consultations, she observed that the COVID-19 pandemic had in many ways been a wake-up call, exposing the international community's vulnerability and lack of preparedness for shocks and crises.
- 73. She reiterated that the Strategic Plan was firmly rooted in the 2030 Agenda and its framework for renewed multilateralism and international collaboration on shared challenges.
- 74. Drawing attention to a section in the Plan on IDLO's comparative advantages as identified by stakeholders, she stressed how important it was to have clarity in this regard in an ever more crowded development sector with multiple actors working on interrelated issues.
- 75. She also highlighted IDLO's vision and mission statements, as well as the eight core values lying at the heart of its work, as outlined in the document.

- 76. Introducing the substantive components of the Strategic Plan 2021-2024, the Director-General described the document's two new overarching Strategic Goals and six Strategic Objectives, and presented plans for their achievement over the next two years under the 2021-2022 Management Plan.
- 77. The Director-General also highlighted the three essential, cross-cutting principles inclusion, integration and innovation that would underpin all of IDLO's work.
- 78. Commenting on Goal 1 of the Plan ("justice systems are more effective and responsive to people's needs") the Director-General noted that "people-centered justice" was a key concept underlying the plan as a whole. She went on to present the three Strategic Objectives under Goal 1, namely: empowering justice seekers to claim their rights; making laws and institutions work for people; and reducing the justice gap for women and girls. For each Strategic Objective, the Director-General provided examples of the types of activities that would be undertaken during the first two years covered by the Management Plan.
- 79. Turning to Goal 2 of the Strategic Plan ("rule of law drives peace and sustainable development"), the Director-General referred to SDG16 and SDG5 as a prism through which the rule of law can help drive and accelerate progress throughout the 2030 Agenda and across different dimensions of peacebuilding and sustainable development.
- 80. The Director-General went on to present the three Strategic Objectives included under Goal 2, namely: rule of law drives inclusive economic development; rule of law promotes climate justice and sustainable use of land and natural resources; and rule of law advances healthy lives and well-being for all.
- 81. As she had done in relation to Goal 1, the Director-General provided a range of examples of the types of activities IDLO would carry out under each of the Strategic Objectives of Goal 2.
- 82. The Director-General noted that in 2021 the three objectives of Goal 1 would account for the bulk of IDLO's program portfolio.
- 83. Goal 2 for its part sought to open up promising new opportunities in key areas of peacebuilding and sustainable development where the rule of law can play an important catalytic role and where IDLO enjoys a comparative advantage and a track record but has had relatively limited programming to date. She pointed to inclusive economic development, climate justice, sustainable use of land and natural resources, food security and health law as areas in which IDLO would aim to increase its presence and leverage its mandate over the next two years.
- 84. Geographically, Africa would continue to be IDLO's largest region of operations, accounting for just over a third of program revenue. At the same time, she said, IDLO would continue efforts to diversify and expand its presence globally, including strengthening its operations in the MENA region.

- 85. The Director-General reiterated in this context the intention of increasing engagement with regional organizations such as the African Union, ASEAN and the European Union.
- 86. Underlining the importance of having systems, processes, capacities and a resource base that are fit for purpose to deliver on the goals of the Plan, the Director-General went on to present the four organizational Enablers that had been identified in this light in the Plan namely: enhancing innovation, integration, and impact; investing in people; improving systems and processes; and strengthening partnerships.
- 87. On resource mobilization, she observed that under the new Plan IDLO would seek to build funding partnerships with both traditional and non-traditional donors, including not only governments but also private sector organizations and foundations.
- 88. A strategic approach would also be taken to increase IDLO's membership, with a focus on achieving a balanced and representative expansion and giving priority to countries with an active interest in IDLO's mandate and programming.
- 89. The Director-General reported that IDLO would also further develop a crosscutting Gender Action Plan, geared to reinforcing gender equality across the Organization, as well as mainstreaming a gender focus throughout IDLO's work.
- 90. Turning to the Operating Budget, the Director-General reiterated that it was a balanced budget prepared in a rapidly evolving environment, and provided an overview of its key components, stressing the cautious approach that had been adopted when forecasting levels of revenue for 2021.
- 91. Summing up the thrust of the new Strategic Plan, the Director-General presented its main purpose as that of leveraging IDLO's programs, research, policy and advocacy to advance people-centered justice and the contribution of rule of law to the promotion of peace, human rights and sustainable development.
- 92. With regard to the Management Plan 2021-2022, she reiterated that it was intended to be ambitious but realistic, and to build on current strengths while also furthering IDLO's ability to seize and be responsive to new opportunities. Finally, she described the Operating Budget 2021 as reflecting IDLO's conservative and flexible approach to budgeting and financial management in a challenging global environment.
- 93. She concluded by remarking that building a culture of justice requires time, effort and sustained commitment, but that "it is the best investment we can make in our collective future."

- 94. The President thanked the Director-General for her presentation and opened the floor for interventions from Member Parties.
- 95. The Assembly heard interventions by the representatives of Italy, Kuwait, Mozambique, the Netherlands, Pakistan, Peru and the United States.
- 96. Representatives conveyed strong support and endorsement of IDLO's new Strategic Plan 2021-2024, which they viewed as an excellent roadmap to guide the Organization during the next four-year cycle. They also expressed full approval of IDLO's Management Plan 2021-2022 and the 2021 budget.
- 97. Representatives also commended the extensive and inclusive consultative process that had taken place for the development of the Plan, welcoming its focus on people-centered justice and its close alignment with the goals of the 2030 Agenda.
- 98. Several representatives also expressed particular appreciation for the clear way in which the Plan set forth IDLO's comparative advantages and built on strengths and lessons learned from the previous plan, while opening opportunities for new activities in important thematic areas, such as climate justice, health law and e-justice.
- 99. Representatives also welcomed the emphasis in the Plan on further strengthening IDLO's partnerships, particularly with the UN system, Romebased agencies and regional organizations.
- 100. The representative of the United States welcomed the establishment of the new Department of External Relations and Partnerships and said that his Mission looked forward to engaging with the new Department and to lending whatever assistance it could in identifying new sources of political and financial support, as well as new partnerships. He also called on other Member Parties to further strengthen their engagement with IDLO, since each has a unique perspective to offer in reinforcing the institution.
- 101. The Director-General expressed her appreciation for all Member Parties' interventions, thanking them for their endorsement of the new Strategic Plan and approval of the Management Plan and Budget, and for their support for the people-centered approach to justice that guided these documents. On the subject of partnerships, which she reiterated was one of her major priorities, the Director-General highlighted the planned participation of the Director-General of WHO, the Administrator of UNDP, the President of ECOSOC and other high-level speakers in the Assembly's thematic afternoon session.
- 102. She also called attention to IDLO's plans to develop regional and country strategies, as part of the effort to move from a project-based approach to a programmatic one.
- 103. Commenting further on IDLO's work on anti-corruption, she reported that an effort was already well underway to strengthen IDLO's relationship with UNODC, and that IDLO was participating in preparatory work for the 2021 UN General Assembly special session on anti-corruption and would be

- collaborating with the Working Group on anti-corruption during Italy's forthcoming G20 presidency.
- 104. She thanked once again Member Parties for their political and financial support, particularly during such challenging times, and said she looked forward to continuing to work with all of them in building a global culture of justice.
- 105. Concluding the discussion of agenda item 3, the President drew attention to the draft Resolution N.1/2020 endorsing the proposed Strategic Plan 2021-2024, which had been shared with Member Parties in advance of the meeting.
- 106. Noting there were no objections or additional comments, the President declared Resolution N.1/2020 (AP/2020/3.2) adopted by consensus.
- 107. She then drew attention to Resolution N.2/2020 approving the Management Plan 2021-2022 and Budget 2021, a draft of which had also been shared in advance with members. Noting there were no objections or additional comments, the President declared Resolution N.2/2020 (AP/2020/3.5) adopted by consensus.

AGENDA ITEM 4: HOST COUNTRY AGREEMENTS

- 108. The President introduced this item by referring to the Report, prepared by the Secretariat (AP/2020/4.1) at the request of Member Parties at last year's Assembly of Parties. She also drew attention to the draft Resolution N.3/2020 submitted to the Assembly for its approval. She then gave the floor to the Director-General to introduce the report.
- 109. The Director-General began by emphasizing the importance of Host Country Agreements for ensuring the safety and security of IDLO staff, adding that she regards finalizing such agreements as a major priority.
- 110. She recalled the key features of the resolution on HCAs adopted by the Assembly in 2019 and went on to describe HCAs as essential to IDLO's ability to operate effectively and securely, noting that in countries where IDLO did not have agreements in place it faced a range of challenges including political, reputational, logistical and financial risks.
- 111. She expressed satisfaction at having signed four HCAs during 2020, with three Member Parties Burkina Faso, Mongolia and Uganda and with Niger, and said she looked forward to concluding more such agreements in the year to come. She then asked IDLO's General Counsel to briefly summarize the HCA report.
- 112. The General Counsel provided an overview of the progress made during 2020, the various challenges faced by the Organization both in securing agreements and in operating in countries without such agreements, as well as what was planned in terms of next steps. He also drew attention to the annex to the report, which provides the state of play with regards to the recognition of IDLO's legal status in its countries of operation. Noting that the recognition of

- IDLO's legal status was identified as a priority in both the Strategic Plan and Management Plan, he concluded by underlining the importance of Member Parties' support in supplementing IDLO's efforts to conclude such agreements.
- 113. Following the presentation of the Report, the President opened the floor for comments.
- 114. The representative of Burkina Faso expressed satisfaction for the conclusion during 2020 of an HCA with IDLO. Referring to the start-up of the Sahel program he said that Burkina Faso was keen to collaborate with IDLO and described IDLO's assistance as instrumental to progress in the region.
- 115. The representative of the United States thanked IDLO for the HCA report, noting that it clearly illustrated the benefits of such agreements in terms of protecting IDLO personnel, programs and budgets. He endorsed the call for more active involvement of Member Parties, particularly those that benefit from IDLO programming, and said the United States welcomed the Director-General's engagement on the issue and its continued prioritization. He expressed hope that additional agreements would be concluded in the future and welcomed guidance from the IDLO Secretariat on the kind of support it required in this effort.
- 116. The representative of Uganda referred to the signature of the HCA between IDLO and her Government, describing it as a reflection of her country's commitment to IDLO. She referred to the legal steps required to formalize the implementation of the agreement and said that the authorities in Uganda were working hard to ensure that this would be done as soon as possible.
- 117. The President invited the Member Parties to consider the proposed Resolution which had been submitted for approval by the Standing Committee. Absent any objections, Resolution N.3/2020 (AP/2020/4.2) was approved by consensus.

AGENDA ITEM 5: REPORTS OF THE GOVERNING BODIES

REPORT OF THE STANDING COMMITTEE (AP/2020/5.1)

- 118. The President presented the Report of the Standing Committee (AP/2020/5.1) which had been circulated in advance to the Member Parties, providing a summary of the report's main highlights and details of the three meetings held by the Committee in 2020.
- 119. She acknowledged the efforts of IDLO's staff in preparing effectively for each virtual meeting of the Standing Committee to ensure they ran smoothly.
- 120. She also referred to a special briefing and consultation on the new Strategic Plan, which the Director-General held with Standing Committee members following the Committee's first meeting in April 2020.

- 121. The President expressed appreciation for the Director-General's reports to the Standing Committee, including her regular updates on IDLO's contributions to the global effort to tackle the COVID-19 pandemic.
- 122. Finally, the President reviewed the main decisions taken by the Committee during 2020, including: approval of IDLO's audited Financial Statements for 2019, which for the first time were compliant with International Public Sector Accounting Standards (IPSAS); approval of projects funded from the Operational Fund; endorsement of IDLO's Strategic Plan 2021-2024; approval of the draft Management Plan 2021-2022 and proposed Operating Budget 2021; and approval of the draft resolutions before the Assembly.

REPORT OF THE AUDIT AND FINANCE COMMITTEE (AP/2020/5.2)

- 123. The President then gave the floor to Mr. Filippo Alessi (Italy), Chair of the Audit and Finance Committee (AFC), to provide a summary of the AFC Report to the Assembly for 2020.
- 124. The AFC Chair began by noting that 2020 had been a busy year for the AFC with five meetings being held, all virtually due to the pandemic restrictions.
- 125. He referred to the expansion of the AFC's membership from five to seven members following a reform agreed upon in 2019 as a very positive development and said that he looked forward to the Committee continuing to operate with the same number of members as a result of the upcoming elections.
- 126. He noted that a key priority for the AFC during 2020 had been to monitor the impact of the global pandemic on IDLO finances and expressed appreciation for the regular updates provided by the Secretariat in this regard throughout the year.
- 127. He welcomed the close collaboration between IDLO's Finance and Programs Departments, also in light of the high percentage that program revenue represents in IDLO's budget.
- 128. He noted that while the COVID-19 pandemic had undoubtedly complicated program delivery in the field, a number of new program agreements had been signed during the year, helping to mitigate the effects of delays in implementing ongoing programs. As a result, he said, the end of year figures forecast for 2020 were in line with those budgeted for the year.
- 129. The AFC Chair concluded by thanking members for their active participation during 2020 and saying that he looked forward to continuing his positive engagement with the AFC during 2021.
- 130. There were no comments from Member Parties on the reports of the Standing Committee and the Audit and Finance Committee.

AGENDA ITEM 6: REPORT OF THE BOARD OF ADVISERS (AP/2020/6.1)

- 131. The President noted that the IDLO Secretariat had not received a report from the Board of Advisers for the current year.
- 132. She further observed that this was a period of significant transition in the membership of the Board of Advisers and referred in this context to earlier comments by Member Parties that had submitted nominations for candidates to fill vacant positions on the Board. She concluded by saying that she looked forward to a reinvigorated Board of Advisers moving into the next year to help support IDLO's good work around the world.
- 133. There were no comments from Member Parties on this agenda item.

AGENDA ITEM 7: ELECTIONS

- 134. The President began by summarizing the different elections scheduled to take place, namely:
 - One Member Party to serve as President of the Assembly of Parties
 - One Member Party to serve as Vice-President of the Assembly of Parties
 - Two Member Parties to serve as ad hoc members of the Standing Committee
 - A minimum of one (1) and a maximum of three (3) Member Parties to serve as members of the Audit and Finance Committee; and
 - A minimum of three (3) and up to seven (7) individuals to serve as members of the Board of Advisers.
- 135. She drew attention to the background notes on the elections which were circulated prior to the meeting (AP/2020/B1 and AP/2020/B2), as well as a note (AP/2020/B3) outlining the election procedures and modalities for online voting in the event that voting was required.

AGENDA ITEM 7(a)1: ELECTION OF PRESIDENT

- 136. The President recalled that the United States, having served as President of the IDLO Assembly of Parties for a three-year term, could not be re-elected to that position. She noted that Pakistan had expressed interest in the position and asked if any other Member Parties wished to announce their candidacy. Noting there were no requests for the floor and that there was consensus of the Member Parties on Pakistan's candidature, the President declared Pakistan the new President of the Assembly of Parties and gave the floor to the Ambassador of Pakistan to provide remarks.
- 137. The Ambassador of Pakistan thanked Member Parties for their support and confidence in electing Pakistan as President, saying that he felt humbled and honored to serve in this position.
- 138. He recognized the contribution of the United States as outgoing President and expressed his appreciation to the Director-General and IDLO staff.

- 139. Commending the work of IDLO, the Ambassador said that Pakistan fully shared IDLO's belief that many of the root causes of conflict and instability stem from a lack of rule of law and its vision of a culture of justice as an essential foundation to sustain peace and development.
- 140. He noted that Pakistan has been consistently engaged in IDLO's governance since joining the Organization in 2015, having served on the Standing Committee as well as the AFC.
- 141. Acknowledging the many challenges to achieving a global culture of justice, the Ambassador said that Pakistan looked forward to working closely with IDLO management and its Member Parties to broaden IDLO's scope of work, increase its membership and geographical diversification, and achieve its main policy and program objectives.
- 142. The President expressed congratulations once again to the newly elected President and said she looked forward to working under Pakistan's able leadership.

AGENDA ITEM 7(a)2: ELECTION OF VICE-PRESIDENT

- 143. Noting that the United States was a candidate for the position of Vice-President, the President gave the floor to Italy, as *de jure* Vice-President, to conduct this election.
- 144. The Vice-President recalled that the United States had expressed interest in the position of Vice-President and asked if any other Member Parties wished to announce their candidacy. Noting there were no requests for the floor, and that there was consensus among the Member Parties, the Vice-President declared the United States elected as the new Vice-President of the Assembly of Parties and conveyed Italy's congratulations to the United States on its election.
- 145. Resolution N.4/2020 (AP/2020/7.1), recording the result of the election of the President and Vice-President, was then shared on screen by the IDLO Secretariat and subsequently adopted by consensus. The Vice-President returned the floor to the President to resume chairing the meeting.

AGENDA ITEM 7(b): ELECTION OF TWO AD HOC MEMBERS OF THE STANDING COMMITTEE

- 146. The President introduced the election, noting that there were two vacancies arising from the end of the terms of Ecuador and Turkey. She further noted that expressions of interest had been received from Ecuador and Senegal.
- 147. The President asked whether any additional Member Parties wished to announce their candidacy for a two-year term on the Standing Committee. Noting that there were no additional expressions of interest, and that there was consensus among the Member Parties, the President declared Ecuador and Senegal elected to serve as members of the Standing Committee for a two-year term.

148. Resolution N.5/2020 (AP/2020/7.2), recording the result of the elections to the Standing Committee, was shared on screen and subsequently adopted by consensus. The President expressed congratulations to the new members elected to serve on the Standing Committee.

AGENDA ITEM 7(c): ELECTION OF ONE TO THREE MEMBERS OF THE AUDIT AND FINANCE COMMITTEE

- 149. Noting that the United States was also among the candidates for the Audit and Finance Committee the President again gave the floor to Italy as *de jure* Vice-President to conduct this election.
- 150. The Vice-President recalled that the AFC can have between five and seven members and that four of its current members could serve for another year. She noted that there were therefore a minimum of one and a maximum of three seats available on the Committee, and that China, Kenya and the United States had all expressed interest in being elected to the Committee.
- 151. The Vice-President asked if any other Member Parties wished to announce their candidacy for the AFC. Noting there were no requests for the floor, and that there was consensus of the Member Parties, the Vice-President declared China, Kenya and the United States elected to serve on the AFC for two-year terms.
- 152. Resolution N.6/2020 (AP/2020/7.3), recording the result of the elections to the Audit and Finance Committee, was shared on screen and subsequently adopted by consensus. The Vice-President expressed congratulations to the new members elected to serve on the Committee and returned the floor to the President to resume chairing the meeting.

AGENDA ITEM 7(d): ELECTION OF MEMBERS OF THE BOARD OF ADVISERS

- 153. The President introduced the election, noting that the Board of Advisers should have at least six and no more than ten members and that six of the current members were completing their terms of office. On behalf of the Member Parties, she thanked the outgoing members of the Board for their service to IDLO during the past eight years.
- 154. She further noted that the Assembly was called upon this year to elect at least three and no more than seven members, including one Italian citizen. She advised that the following five nominations had been received in advance of the meeting and that information on the nominees, including their CVs, had been shared:
 - Dr. Ruth Aura-Odhiambo (nomination by the Republic of Kenya);
 - Ambassador Mehmet Hasan Gögüş (nomination by the Republic of Turkey);
 - Dr. Hoang Ly Anh (nomination by the Socialist Republic of Viet Nam);

- Mr. Stefano Manservisi (nomination by the Republic of Italy); and
- Prof. Githu Muigai (nomination by the Republic of Kenya).
- 155. She asked if any Member Parties wished to submit additional candidates for the Board. Noting there were no such requests, and that there was consensus for the five nominees submitted, the President declared the five aforementioned candidates elected to serve on the Board of Advisers for a fouryear term, ending in 2024.
- 156. Resolution N.7/2020 (AP/2019/7.4), recording the result of the election, was subsequently shared on screen and adopted by consensus. The President asked the Secretariat to notify the newly elected members to the Board of the result and to provide them with any relevant information in relation to their membership and service.

AGENDA ITEM 8: ANY OTHER BUSINESS

- 157. No Member Parties raised any issues under this agenda item.
- 158. The President thanked the Member Parties for their active participation and continued commitment to IDLO. She also thanked IDLO's Director-General and staff for their hard work, particularly during what has been an extremely challenging year. She congratulated the new President of the Assembly and the newly elected members of IDLO's governing bodies and of the Board of Advisers.
- 159. Finally, she reminded Member Parties to join the afternoon session of the Assembly for the thematic discussion "Partnering to Advance the Rule of Law in Challenging Times: Launch of IDLO's Strategic Plan 2021-2024."
- 160. The President then declared the formal session of the Assembly meeting closed.

Madame President, (USA Jennifer Harhigh)

Madame Director General, (Jan Beagle)

Excellencies,

Ladies and Gentlemen,

It is a great pleasure for me to open IDLO's Assembly of Parties. Although Italy traditionally hosts this event at the Farnesina, we unfortunately had to organize it online this year for the reasons we all know.

So far, 2020 has been a year like no other in our lifetime. As Covid-19 sweeps through every corner of the world, affecting everyone and exacerbating inequality and deprivation, world leaders are called to act swiftly to contain this unprecedented threat in order to promote a fast and sustainable recovery.

To do this, the rule of law becomes more essential than ever as the effectiveness of government measures to contain the virus and "Build Back Better" depends on the capacity of public institutions to provide transparent, effective, and accountable policy and actions.

As stated last week by Director General Jan Beagle in her appreciated statement at the Foreign Affairs Committee of the Italian Chamber of Deputies: "the rule of law can play a key role in sustaining peace by helping to address the root causes of conflict and insecurity, which often lie in issues such as discrimination and marginalization, lack of respect for human rights, corruption and impunity".

In my previous decades-long work experience in conflict areas, I could see first-hand how legal empowerment can help reducing inequalities by enabling poor, marginalized and vulnerable groups access essential public services like justice, health and education.

Today, in my position as the Italian Vice Minister in charge of development cooperation, I strongly believe that Sustainable Development, as an enabler of peace, justice and inclusion, can help promote stronger institutions, more successful government action and reduced inequalities to prevent and mitigate disease outbreaks such as COVID-19.

The values and principles expressed by SDG16 become crucial to overcome the ongoing crisis and ensure a just, equitable and sustainable recovery for all.

In this context, IDLO's action is increasingly important, especially if we consider that its mandate – supporting the rule of law and promoting justice as a means for sustainable development – is unique among International organizations and multilateral bodies.

IDLO is contributing to global efforts to promote peace and development through the rule of law, protect the most vulnerable, and move towards more inclusive, sustainable and resilient societies.

Italy, as an active member of the international community and within the European Union, is pushing for increasing investments in the rule of law sector and access to Justice, as a fundamental component of sustainable development, especially at these challenging times.

Protecting and promoting human rights and fundamental freedoms, in accordance with our Constitution, has always been at the heart of Italy's policy and action, both at the national and international level.

As a member of the United Nations' Human Rights Council for the 2019-2021 mandate and as a candidate country for the next term, Italy is particularly committed to the fight against all forms of discrimination; the promotion of the rights of women and children and the protection of the rights of persons with disabilities; the establishment of a universal moratorium against the death penalty; the protection of freedom of religion or belief and the rights of persons belonging to religious minorities; the fight against human trafficking and the protection of human rights defenders.

Italy is also playing a leading role in the fight against corruption, especially in the context of the upcoming Italian G20 Presidency. As leaders of the G20 Anticorruption Working Group, we will adopt a holistic vision for the fight against corruption by focusing on new forms of corruption that are emerging in the global economy, especially if we consider the new risks linked with the health crisis.

As we play a primary role in capacity building, institution building, law enforcement and consensus building initiatives, we are convinced that strengthening multilateral cooperation is the only way to overcome the current crisis. This is why we have invited IDLO to attend the G20 Anti-corruption Working Group that will be held under our leadership.

Considering the importance we bestow on our collaboration with IDLO, we invited its Director General, Ms. Jan Beagle, to open —as guest speaker- the 5th session of the Development cooperation joint steering committee that will take place on the 14th of December.

Furthermore, as you already know, Italy presented the candidature of Mr. Stefano Manservisi as Italian delegate of the Board of Advisers, in view of the elections that will take place later. I am convinced that Mr. Manservisi's valuable and extensive experience in the field of development cooperation will confer an added value to IDLO activities, programs and international relevance.

Ladies and Gentlemen,

In recent years we have worked together to consolidate IDLO's role and activities and we now see its increasing relevance as an important component of Rome's international organizations' hub.

We welcome the ever-stronger partnerships IDLO has been building in recent years with the UN development system, both in Rome and in New York, with our active support.

We are also pleased with the Covid-19 response IDLO is providing, in partnership with FAO, with a project aimed at mitigating the impact of emergency laws and regulations on access to food, particularly for marginalized and vulnerable groups.

This is consistent with IDLO's commitment to strengthen legal and policy frameworks on pandemic preparedness and response to public health emergencies in collaboration with the World Health Organization.

It also runs in parallel with IDLO's efforts to enhance justice for women and girls, especially in the context of COVID-19, by supporting access to justice to overcome ongoing restrictions on

mobility and improve efficiency and transparency in the administration of justice in Countries like Afghanistan, Kenya, Somalia, and Tunisia.

Besides these positive trends, in order to achieve its mandate IDLO needs a renewed commitment, both financial and political, from all of us.

We have already confirmed our substantial financial contribution to the Organization for 2020 and we hope that other Members will join us, in accordance with their respective capacity, by ensuring their active support to IDLO's core functions, as well as to the implementation of the important projects it carries out on the ground.

Let us join our forces to achieve sustainable development and peace through accountable Institutions and universal access to justice everywhere: supporting IDLO can really make a difference.

I wish you a very fruitful and constructive debate.

PRESIDENT'S STATEMENT

MEETING OF THE ASSEMBLY OF PARTIES 2020 24 NOVEMBER 2020

The United States is proud to have helped guide the International Development Law Organization as President over the past three years. These have been extremely productive years for IDLO. IDLO has added four new member parties, elected and successfully transitioned to a new and highly effective Director General, and brought on dynamic new staff members.

Programmatically, IDLO has responded to increased demand for its high-quality programming to advance the rule of law and access to justice for all. Operationally, IDLO has opened new field offices; increased its collaboration with other UN agencies, especially those here in Rome; and concluded Host Country Agreements with Burkina Faso, Mongolia, Niger, and Uganda that provide IDLO staff and partners with appropriate legal protections. And IDLO has achieved much of this during a global pandemic, rapidly adopting new modes of communications and outreach while ensuring the well-being of its most important asset, IDLO staff.

IDLO's trajectory is therefore very clear and very encouraging – IDLO is on pace for continued growth and an ever-greater impact globally. At the same time, IDLO's successes, combined with the high-level interventions by Director-General Jan Beagle, are helping to elevate the rule of law in global policy discussions around sustainable peace and economic development. IDLO's partnerships with the Rome-based UN agencies are having the same effect, producing concrete results via joint programming, events, and the Director-General's participation in the UN Security Management Team for Italy.

IDLO's growth has meant more work for us member parties, especially those of us that actively participate in IDLO governance committees. Here, I would like to thank my fellow Bureau members Italy and Mozambique for their leadership and advocacy. I would also like to recognize fellow Standing Committee members Turkey, the Philippines, Kuwait and Ecuador. The Audit and Finance Committee, ably chaired by Mr. Filippo Alessi of Italy, has succeeded because of the active participation of Turkey, Senegal, Peru, Pakistan, and Kuwait. These committees play an essential role in ensuring member party input to and oversight of IDLO operations. I strongly encourage all member states to consider joining one of these committees in the years ahead.

Looking forward, the United States welcomes the ambitious performance targets laid out in IDLO's Strategic Plan, Management Plan, and Budget. We wholly agree with the assessment that COVID-19 has shown a light on existing inequalities worldwide in access to justice, exacerbated persistent problems such as gender-based violence, and made clear the need for innovative solutions including e-justice. We also wholly agree that any <u>sustainable</u> recovery must be based on justice and the rule of law for all. Today's discussions are therefore extremely important, in setting this one-of-a-kind intergovernmental organization on a course to make the greatest possible impact in the years ahead.

Ladies and Gentlemen

I am honoured but humbled to make this statement on behalf of the Government of the Republic of Liberia on the occasion of the Annual Meeting of the Assembly of Parties taking place in Rome. This Meeting is taking place at a time when the world is faced with a global pandemic occasioned by uncertainties and challenges such as being unable to meet physically today. I wish to pay tribute to the host country, Italy for the human and other losses it has and continue to endure as a result of this pandemic. The IDLO's work therefore in the aspect of Trafficking in Persons (TIP), is a crucial intervention in the Liberian context. Given that the scourge of human trafficking the world over is significant and highly devastating in its effects. Yet the intricacies involved in the trafficking trade are highly sophisticated and require specialized knowledge to counter. Thus the Government's effort can only go so far given the resource constraints we have as a country. Therefore, as a Government, we sincerely thank and appreciate the IDLO for an intervention of this nature.

We carry the same sentiment for the significant work done on Gender-based Violence (GBV). It is trite that Gender-based violence amongst our societies remains a pertinent issue and it continues to be a global call to end GBV. Thus we cannot downplay the significance of the work done in this area by the IDLO and we appreciate it profoundly as a Country.

Lastly, we take this opportunity to appreciate the IDLO's new Strategic Plan 2021-2024 which has been presented here today. We note that the plan is indeed anchored in the 2030 Agenda. STATEMENT OF THE NETHERLANDS

This year has been a year of change for IDLO. A new Director General, development of your new Strategic Plan and of course adaptation of your work to respond to the COVID crisis.

The Netherlands is pleased with progress made and remains committed to its partnership with IDLO. We commend IDLO, as well as the various committees present here today, for your continuous efforts at country and global levels, as well as your leadership in drawing attention to the impact of Covid-19 on the rule of law and justice. We built in a special focus on 'those furthest behind', including children, women, IDPs, refugees and migrants, detainees and victims of massive human rights violations. Too long, justice systems have been serving the few, rather than the many. These groups often face structural injustices, which have to be addressed.

Lastly, we aim to continue to build a global community of countries that commit to promoting SDG 16.3 and to make people-centered justice the new normal.

We already work with many partners to promote national action and leadership for justice at the local, national, regional and global levels. We will continue these efforts and welcome other countries to join us. Also, collaboration and coordination amongst donors, international organizations and NGOs supporting justice is important. Almost 20 years after the Accra Agenda for Action and Paris Declaration, support is all too often still provided in silos without joint efforts to maximize impact.

We also hope that more funding will be made available for this important area, both at national levels through state governments and through assistance of international organizations, bilateral

donors and the World Bank. We are for example very pleased to see that the World Bank has included justice as an area of focus in their new Fragility, Conflict and Violence strategy.

We believe that this gathering today, with IDLO and its Member Parties, forms an opportunity to join forces to promote SDG 16.3 and call for more political and financial commitments at country and global levels. And we look forward to working with you in advancing these goals.

STATEMENT OF PAKISTAN

We have been working with IDLO in improving provision of inclusive justice to all Ugandans with funding from the Government of Sweden, and Uganda is currently implementing the five-year Euro 15 Million Community Justice Programme (CJP). In spite of the fact that the roll-out of the CJP was affected by the delay in the conclusion of the Host Country Agreement and the COVID-19 pandemic, steady progress is being made in its implementation. As part of this roll-out, IDLO is the process of signing of the Cooperation Agreement with the Government of Uganda that will enable the provision of technical and financial assistance, amounting to about Euro 6.85 Million, through the Ministry of Finance, Planning and Economic Development and the Ministry of Justice and Constitutional Affairs (MOJCA) to support key state institutions within the Uganda Justice, Law and Order Sector (JLOS), in various areas aimed at strengthening the provision and access of justice to all categories of people of the Ugandan society. The list is long but we would like to register our gratitude to Sweden and IDLO for this assistance.

We continue to register our gratitude to IDLO because it has also since July 2020 been providing financial support under the Community Justice Programme to three non-state legal aid service providers, Uganda Law Society, International Association of Women Lawyers-Uganda Chapter and the Legal Aid Service Providers Network (LASPNET) to provide legal aid services in 11 districts across the country and also engage in legal aid-related policy reform processes. An additional 7 other civil society organisations are being assessed for similar sub-granting support under the CJP from the 1st quarter of 2021. IDLO has also since September 2020 been providing technical support to the National Association of Women Judges in Uganda (NAWJU) in strengthening capacities of women judges and other judicial officers to dispense gender responsive and sensitive justice and to strengthen overall participation of women in justice dispensation in Uganda.

As indicated repot, only recently, as part of the global COVID-19 response, IDLO on 8 October 2020, hosted key East African justice actors in a regional webinar in which Uganda's, Director of Public Prosecutions and the President of Uganda Law Society participated and shared how they have ensured sustenance of justice services in the country following the outbreak of the COVID-19 pandemic. IDLO provided them with this platform in which they shared with other participants from the East African region how they have innovatively adopted the use of ICT in

enhancing access to justice during the lockdowns including e-filing of cases, audio-visual court proceedings, web-based legal aid tools and strengthened coordination among the justice actors. We are grateful for this intervention from IDLO for availing this support to state and non-state justice actors to respond to the evolving justice challenges brought about by the pandemic in Uganda.

Our relationship with IDLO is vibrant and growing from strength to strength. IDLO has in the past enabled Uganda to participate in the May 2019 Global Forum on SDG 16 ahead of the UN High-Level Political Forums (HLPFs) in Rome, Italy, in which the Government Chief Whip, the then Deputy Chief Justice (now the Chief Justice) formally represented Uganda.

IDLO is also currently developing the "Strengthening Food Security for Vulnerable Groups, Women and Girls as part of the Covid-19 Response" Project towards contributing to enhancing food security and access to food for vulnerable populations, women and girls in times of emergency response and recovery, including in the context of COVID-19. Future programming in such areas as protection of biodiversity including through strengthening of legal framework for land and natural resources management, shall also be explored in line with the new IDLO Global Strategy.

We remain committed to continue working with IDLO its endeavour to support Uganda in the implementation of the provision and access of justice to all her citizens.

STATEMENT OF THE UNITED STATES

First, I would like to welcome the Director-General to her first Assembly of Parties. Director-General Beagle, the United States appreciates your leadership and strategic vision for IDLO. In particular, we applied your demonstrated commitment to open dialogue with IDLO member parties, as well as your tireless promotion of the rule of law and access to justice as essential components for sustainable development and lasting peace.

I would also like to recognize today's high-level representation by member parties. I have first-hand experience of just how busy your schedules are: many of you are working to find solutions to reverse troubling trends in hunger and malnutrition; others oversee bilateral relations with our extremely dynamic host country; and some of you somehow manage to do both. Your presence here today reflects the fundamental truth that sustainable development and lasting peace depend on the rule of law, now more so than ever.

With respect to the DG's report, the United States commends IDLO on its adherence to its core principles of Inclusion, Integration, and Innovation during this year of unprecedented challenges. As the only intergovernmental organization exclusively dedicated to the rule of law as an enabler of peace, sustainable development, and human rights, IDLO is uniquely positioned to build judicial capacity in challenging operating environments. We commend IDLO for its rapid shift to today's realities through greater user of webinars, for example, and your success in utilizing technology to sustain a busy schedule of trainings and project oversight work. As a result, IDLO has managed to largely keep pace with its pre-pandemic objectives without compromising the safety and wellbeing of its staff and partners.

The United States welcomes IDLO's work to promote inclusive economic development. I cannot stress enough the importance of this work. All countries are facing immense popular pressure to accelerate their nation's economic recovery. Experience shows us, however, that this pressure can compel states to pursue shortcuts and/or fall victim to predatory loans and investments, undermining the prospects for economic growth and political stability for years to come. IDLO's capacity building and anti-corruption programs help level the economic playing field. Economic justice, at the individual and societal levels, is a non-negotiable requirement for sustainable, long-term economic growth.

Ultimately, the proof is in the pudding. The wide range of activities captured in the DG's report to this Assembly accurately captures IDLO's unique mandate and capabilities. Each of these areas – from increasing access to justice for vulnerable populations, to combating gender based violence, to improving justice sector effectiveness – urgently demands the world's attention.

We, IDLO's 37 member parties, also have our work cut out for us. We need to work together to promote IDLO's impact amongst policymakers in our capitals, and in the capitals of our neighbors and partners. We need to introduce IDLO to non-governmental organizations, including the large foundations and corporate social responsibility entities that could bolster IDLO's work with resources and expertise. We should all be encouraged by rapidly growing global demand for capacity building in the justice sector. We need to work together to enable IDLO to expand its impact to meet this demand, while also ensuring that IDLO's growth does not come at the expense of the organization's excellent communication with member states and sound oversight processes.

With that, the United States very much looks forward to today's Assembly of Parties meeting, including discussion of the Strategic Plan, Management Plan, and Budget; an update on progress made securing Host Country Agreements, which protect our collective investment in IDLO's work; and Elections to the Standing Committee, Audit and Finance Committee, and Board of

Advisors, each on which will play a crucial role in shaping IDLO plans and operations in the years ahead.

STATEMENT OF THE NETHERLANDS

Thank you for having presented your Strategic Plan, Management Plan and Budget. We have also appreciated the extensive consultation process in compiling it.

There are many synergies between IDLO's Strategic Plan and our own Access to Justice Strategy. We welcome your people-centred focus in the Strategic Plan. We see many specific strengths that IDLO brings to the table, for example:

Your diverse membership

Your specialized mandate and strong expertise in a number of crucial areas, including for instance in health and the law (particularly important now in the context of Covid19), in gender, and in informal justice systems.

We know you are aiming to move away from a project-based organization to larger, longer-term programmes and engagement. A key step forward to accomplish this is to increasingly work on the basis of regional and country-specific overarching strategies, based on solid data, that can guide project development at country levels. As donors, we also carry a responsibility here. We should seek coherence and coordination in our initiatives and avoid operating in silos. Country strategies developed in consultation with host governments, justice stakeholders, communities, civil society and other international rule of law actors can facilitate this.

We welcome the enablers presented in your management plan.

You focus on digitalization and innovation are important and we will be interested to collaborate on this.

Efforts to increasingly work through evidence-based approaches and with a focus on results and impact are welcomed. We consider this very important and look forward to working with you on this.

Partnerships are very important. We are encouraged by the increasing collaboration between IDLO and the UN, including the UN Peacebuilding Fund and there are other positive examples such as the collaboration between IDLO and UNDP in Somalia. However, there also still seem to exist obstacles to work closely together and it does not always succeed. We believe such cooperation should become the norm instead of the exception.

We would also encourage IDLO to continue to join forces with actors like Pathfinders, CIC, and the UN to keep drawing global attention to the need for political and financial commitments to SDG 16.

As the Netherlands, we are happy to engage in consultations with you to initiate an overarching strategic partnership, which can guide and include assistance at country levels. We look forward to working with you on this, as well as engage with other Member Parties and donors of IDLO.

STATEMENT OF PAKISTAN

Thank you Chair,

The strategic plan discussed here comprehensively charts out IDLO's goals and targets, along with a concrete plan of action. I notice that the plan builds upon organization's experience from strategy 2020, aligning IDLO's aims; not just with its core mission, but also with Sustainable Development Agenda 2030.

It is appreciable that IDLO has framed its three-year strategy taking into account core shared values; such as promoting rule of law, sustainability, human rights, gender equality, legal pluralism and inclusivity. The organization's focus on justice, capacity building and local ownership, with a people-centric approach, aimed at closing the justice gap -- so as to provide easy access to justice for all; especially to the most marginalized and vulnerable populations; is commendable.

It is evident that this strategy is a product of a broad-based consultative process; including input of member parties, governing bodies, governments, host country partners, international organizations, academia, media, employees and justice seekers.

I am particularly pleased to note that the Strategic Plan envisages renewed focus on creating a culture of justice, by strengthening institutions, building capacity and providing technical and legal support. The plan has been clearly prepared in light of the new challenges confronting the world -- in particular the ongoing pandemic -- and aims to address the widening justice gap, impact of climate change, technological advances, gender inequality and economic crises.

The strategy has set two main goals. First to work for justice systems more responsive to people's needs, and second to pursue sustainable development through promotion of rule of law. We believe this is very much in keeping with IDLO's mission to improve access to justice through institutional and legal reforms, that in turn empower justice seekers, especially those marginalized by gender, lack of resources, conflict and crises. It also aims to drive economic development, address climate change and cater to public health emergencies, by fostering and solidifying the legal and institutional frameworks.

IDLO has an impressive record in supporting institution building and legal reforms to strengthen rule of law and improve access to economic opportunity, despite political uncertainties and lack of political will in some instances. It is now expanding its horizon, taking on a larger role in re complex dynamics of sustainable development Its increasing collaboration with governments and international organizations in a wider range of areas; such as health, climate change, food security and economic development, reflects the success and significance of its vision.

While the broader role set out by IDLO for itself is praiseworthy, the road ahead would not be an easy one. As a result of the pandemic, we are now faced with growing inequality and deprivation to which no country or society is immune. Then there are the challenges posed by ongoing conflicts, natural disasters, impact of environmental degradation and lack of resources, that hinder access to justice to a significant proportion of the world's population. These marginalized segments have to be IDLO's real target area in the upcoming plan. And we agree with the management that now, more than ever, there is a need to invest in capacities and resources to move forward, so as not to squander all the hard work done in the past.

One area where I would invite particular attention is the need to combat corruption, lack of transparency and inadequate accountability. This is hurting the process of development and empowerment of vulnerable populations in many parts of the world in myriad ways. In Pakistan,

while we endeavour to root out this menace as per our Prime Minister's vision and agenda, so that precious national resources could be used for common good of the people -- rather than being monopolised by those who exploit their positions of power and influence -- we have come to understand how challenging the process is, and how wide ranging are the reforms required.

While we need to promote transparency and accountability at the national levels; we also need to foster greater international cooperation to ensure that any ill-gotten or unidentified wealth could not be parked overseas, or in any off shore havens beyond the reach of national authorities.

It is only by promoting rule of law, equal rights, economic opportunity & access to justice on the one hand, and combating corruption, lack of transparency, gender or resource based vulnerabilities and extremist ideologies, on the other, that we can truly promote democratic culture and sustainable development for the mankind.

We wish IDLO continued success in its great endeavour.

STATEMENT OF PERU
