# **Clarifications and Amendment Letter No: 1**

Reference is made to IDLO RFP N\_1006-HQ\_21 issued on 30 August 2021 for the procurement of Employee Engagement Survey through IDLO Tenders website.

Please find hereunder the queries received and IDLO's response and related amendments to them.

1. **Query 1**: Could you confirm that you require the Survey, and the Results reports to be delivered <u>only</u> in English? Please let us know if you need any additional languages for the Survey and/or for the Result reports.

#### **IDLO** Response:

The official working language is English, however there is a small population of local field-based employees speaking Spanish and French. IDLO may decide to include other languages at the time of the award.

2. **Query 2**: Point 33. on page 11 describes the Payment Terms "within 30 days after satisfactory receipt of all goods and upon submission of the invoice by the Supplier". Will IDLO accommodate a payment term of 50% at the signature of the contract and 50% at the end of the project as per standard commercial terms for such service?

### **IDLO Response:**
