

## REQUEST FOR EXPRESSION OF INTEREST FOR THE PROVISION OF ICT HARDWARE

The International Development Law Organization (IDLO) calls for Expressions of Interest (EOI) qualified and willing national Suppliers.

## About IDLO

IDLO is an intergovernmental organization exclusively devoted to promoting the rule of law. Established in 1983, IDLO works to enable governments and empower people to reform laws and strengthen institutions to promote peace, justice, sustainable development and economic opportunity. Its programs, research and policy advocacy cover the spectrum of rule of law from peace and institution building to social development and economic recovery in countries emerging from conflict and striving towards democracy.

## <u>Purpose</u>

The purpose of the EOI is to pre-qualify Suppliers based on the below criteria. If the Supplier meets the criteria, it will be included in the List of Pre-Qualified Suppliers that are considered to be qualified by IDLO to participate in the subsequent formal solicitation.

The deadline for subsequent formal solicitation will be advised later.

#### **Procurement Arrangements**

The formal solicitation will be used to award a Contract to fulfil IDLO's requirement.

## **Eligibility Criteria**

IDLO Yemen Team requires national Suppliers for the provision of ICT Hardware to be delivered to the Beneficiary located in **Aden**, **Yemen** no later than **28 March 2021**. Eligibility criteria for the requested services include:

- e. Statement Letter whether any import or export licenses are required in respect of goods to be purchased including any restrictions on the country of origin, use/dual use nature of goods
- f. Copies of Product Catalogues/Brochures attesting compliance to Technical Specifications and provision of Serial Numbers
- g. Self-Attestation Letter on Vendor Debarment, Litigation History and Bankruptcy
- h. Copy of POs ort Contract of similar nature
- i. Financial Statements for the past three (3) years

# Procedure for submission of EOI:

The EOI submitted by email must be limited to a maximum of **5MB**, virus-free in one email transmission. Any attachments must be free from any form of virus or corrupted contents, or the EOI shall be rejected.

Step 1: Submit a cover letter expressing the interest in participating in the EOI, with a confirmation that the information submitted is correct and Supplier can deliver Items to Aden, Yemen within the specified timeline. If availability of Items is confirmed and submitted for partial Lots, Items listed must meet outlined specifications.

Step 2: Submit documentations to evidence the Eligibility Criteria

Deadline for Submission of EOI: On or before 16 March 2021 at 1500 Hours Rome, Italy local time.
