Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials.

JV, Consortium or Associations are encouraged for high value, multisectoral requirements when the spectrum of expertise and resources required may not be available within one firm.

The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entity in the joint venture in delivering the requirements of the RFP, both in the Bid and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by IDLO.

15. Only One Bid

The Bidder (including the individual members of any Joint Venture) shall submit only one Bid, either in its own name or as part of a Joint Venture.



	Bids submitted by two (2) or more Bidders shall all be rejected if they are found to have any of the following: a) they have at least one controlling partner, director or shareholder in common; or b) any one of them receive or have received any direct or indirect subsidy from the other/s; or c) they have the same legal representative for purposes of this ITB; or d) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the Bid of, another Bidder regarding this ITB process; e) they are subcontractors to each other's Bid, or a subcontractor to one Bid also submits another Bid under its name as lead Bidder; f) or some key personnel proposed to be in the team of one Bidder participates in more than one Bid received for this ITB process. This condition relating to the personnel, does

16. Late Bids	Any Bid received by IDLO after the deadline for submission of Bids, pursuant to clause <i>Deadline for the submission of Bid</i> , will be rejected and sent back unopened or destroyed unopened if the return cannot be secured unless the Bid was sent by email but was not properly received due to issues in IDLO mailing system.
17. Validity Period of Bids	All Bids will be valid for 90 days from the deadline for submission of Bids. In exceptional circumstances IDLO may request the Bidders to extend the validity of the Bid beyond what has been initially indicated in this ITB. The Bidders shall be invited to confirm the extension in writing, without any modification whatsoever on the Bid. The Bidders may choose not to extend the validity period of the Bid upon request of IDLO.
18. Modification and withdrawal of Bids	The Bidder may modify/withdraw its Bid after the Bid's submission, provided that written notice of the withdrawal is received by IDLO prior to the deadline prescribed for submission of Bids.
	The Bidder's modification/withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of clause Deadline for Submission of Bids.
	No Bid may be modified nor withdrawn after the deadline for submission of Bids.

22. Clarification of Bids	To assist in the examination, evaluation and comparison of Bids, IDLO may at its discretion ask the Bidder for clarification of its Bid. The request for clarification and the response shall be in writing and no change in price or substance of the Bid shall be sought, offered or permitted.		
23. Evaluation of Eligibility and Qualification	In general terms, Bidders that meet the following criteria may be considered qualified: a) They are not included in IDLO Sanctions lists (EU, US, UN); b) They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments, c) They have the necessary similar experience, technical expertise, production capacity where applicable, quality certifications, quality assurance procedures and other resources applicable to the provision of the services required; d) They are able to comply fully with IDLO General Terms and Conditions of Contract and IDLO Supplier Code of Conduct; e) They do not have a consistent history of court/arbitral award decisions against the Bidder; and f) They have a record of timely and satisfactory performance with their clients.		
24. Price variation	Bidders shall not vary their prices for any reason after the deadline of the tender and while the Bid is still valid.		
25. Preliminary Screening	IDLO will screen the Bids' Annex D and E to determine whether they are complete, whether the documents have been properly signed, and whether the Bid is generally in order.		
26. Correction of errors	In the event of a discrepancy between the unit price and the total price, the unit price shall prevail and the total price shall be corrected by IDLO. If the Bidder does not accept the final price based on IDLO's correction of errors, its Bid will be rejected.

TERMS OF REFERENCE FOR FRAMEWORK AGREEMENT TRANSPORTATION SERVICES

1. Purpose of this tender

IDLO issues this ITB for the purpose of soliciting bids from service providers for provision of Ttranposrtion services in Rome, the Rome Province and neighbouring Regions.

2. Requirement

The specific requirement from IDLO covers:

Transportation services required

Lot A In town Transportation services

Lot B Transportation services to/from Fiumicino and Ciampino airports

Lot C Transportation services outside of Rome

Type of vehicles

- 1. Sedan 4 passengers
- 2. Minivan up to 8 passengers
- 3. Minibus up to 16 passengers
- 4. Bus up to 24 passengers
- 5. Bus up to 45 passengers

Minimum Requirement for the vehicle

- 1. The vehicle must have a valid registration, valid number plates and be compliant with applicable norms and regulations.
- The vehicle shall be in sound mechanical and physical condition throughout and be maintained in safe operating conditions at all times. The Contractor shall bear full responsibility for the preventive and remedial maintenance of the vehicle and fuel refill and cost.
- 3. The Contractor shall keep the exterior, windows and interior of the vehicles clean and litter-free at all times.
- 4. Production year for the vehicle should be 2012 and above.

Insurance Coverage

The contractor must comply with relevant national insurance laws and provide insurance coverage for all passengers and third parties.

Punctuality & Safety

- 1. The contractor shall provide the transportation services to the IDLO in a manner that results in the punctual pick-ups of the passenger.
- 2. The contractor shall carry out these services in the full observance of safety and road traffic regulations of the Government of Italy.

Overnight stay

In case of travel where an overnight stay will be require Food and Accommodation for the driver during the travel shall be borne by IDLO.



The Minimum requirements for the driver include:

- 1. The driver shall hold a valid driver's Licence and shall have a minimum of 3 years of prior driving experience.
- 2. The driver shall be trained, fully qualified, and physically able (i.e., sight tested) to perform their duties.
- 3. At all times, the driver shall adhere to acceptable professional behavior standards and have a client-oriented attitude. Unacceptable behavior includes harassment or discrimination based on race, creed, color, sex, age, sexual orientation or national origin.
- 4. The driver shall express a client-oriented attitude and provide professional and polite service to all passengers of the vehicles.
- 5. The driver shall wear appropriate and professional attire.
- 6. The driver shall be able to communicate in English.
- 7. The driver shall provide an active mobile telephone number for communication with passengers.

3. Condition of the Framework Agreement(s)

- a. This ITB is expected to result in Framework Agreement(s) with one or several successful Service Providers.
- b. A Framework Agreement is a type of agreement with its terms and conditions under which procurement of goods or services can be effected over a specified period, but which places no obligation on IDLO to order any minimum or maximum quantity. All terms and conditions including the prices will remain unchanged during the period of the Framework Agreement(s).
- c. The Framework Agreement will be signed for a period of up to 12 months with the possibility of another 12 months extension subject to satisfactory performance, funding and agreement by both parties by amending the Framework Agreement. The overall duration of the Framework Agreement shall not exceed 24 months.
- d. Each Framework Agreement will have its specified list of services, indicating the upper ceiling price agreed at the ITB stage. The upper ceiling price list (as well as discounted rates, if applicable) are provisional and are intended solely for the purposes of evaluation and comparison of Bids and to determine the upper ceiling limit in the Framework Agreement. The Service Providers cannot go beyond the upper ceiling price.
- e. After entering into a Framework Agreement, IDLO shall place bookings on a "need basis".
- f. IDLO shall initiate a Secondary Tender to request confirmation from the Service Provider on its availability and prices on the required dates/days by email. The Service Provider shall confirm by return email within 48 hours (including any applicable discounts).
- g. IDLO shall make award decision based on "lowest priced, most technically acceptable/compliant offer".
- h. The confirmed award shall be in the form of a duly authorized Work Order. The Work Order shall include the number/s of persons/participants, services required, and corresponding amounts shall be indicated for the specific booking / event in each case.



Bookings are made with specific venues and may not be transferrable or sub-contracted to other venue.

- i. By signing the Work Order, the Service Provider is confirming that IDLO may modify the number of participants within ± 20% tolerance and that there is a Free Cancellation Policy within seven days of event.
- j. The Service Provider shall returned the sign copy of the Work Order within 24 hours of receipt by email.
- k. IDLO will review the quality of services and deliverables prior to the end of the first 12 months of the agreement. Subject to satisfactory performance and agreement by both parties, a 12-month extension may be agreed to at the same upper ceiling price, terms and conditions. The maximum overall duration of the Framework Agreement will not exceed 24 months. The upper ceiling price will remain unchanged during the period of Framework Agreement.
- I. IDLO is seeking bids by Lots. Hotel Accommodation and Conference Facilities Services Providers may bid for all lots, for selected lots or partials lots. However the minimum requirements per lot must be fully met.
