By submitting a Bid in response to this information, Bidders are confirming acceptance of IDLO General Terms and Conditions for the Procurement of Goods or Services and IDLO Supplier Code of Conduct in full and; Payment Policy where payment is made within 30 days after delivery of service on presentation of complete and correct invoice.

1. General Considerations	<p>In preparing the Bid, the Bidder is expected to examine the ITB in detail. Material deficiencies in providing the information requested in the ITB may result in rejection of the Bid.</p> <p>The Bidder will not be permitted to take advantage of any errors or omissions in the ITB. Should such errors or omissions be discovered, the Bidder must notify IDLO.</p>
2. Cost of the Bid	<p>The Bidder shall bear all costs associated with the preparation and submission of the Bid.</p> <p>IDLO will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the solicitation.</p>
3. Currency of Bid	<p>Bids shall be nominated exclusively in Indonesian Rupiah.</p> <p><i>Note: Local Suppliers must comply with any applicable laws regarding doing business in other currencies</i></p>
4. Language of the Bid	<p>The Bid and all correspondences and documents relating to the Bid exchanged by the Bidder and IDLO shall be written in the English language.</p>

12. 17. Validity Period of Bids	<p>All Bids will be valid for <b>90 days</b> from the deadline for submission of Bids. In exceptional circumstances IDLO may request the Bidders to extend the validity of the Bid beyond what has been initially indicated in this ITB. The Bidders shall be invited to confirm the extension in writing, without any modification whatsoever on the Bid. The Bidders may choose not to extend the validity period of the Bid upon request of IDLO.</p>
18. Modification and withdrawal of Bids	<p>The Bidder may modify/withdraw its Bid after the Bid's submission, provided that written notice of the withdrawal is received by IDLO prior to the deadline prescribed for submission of Bids.</p>

	<p>The Bidder's modification/withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of clause Deadline for Submission of Bids.</p> <p>No Bid may be modified nor withdrawn after the deadline for submission of Bids.</p> <p>No Bid may be modified/withdrawn in the Interval between the deadline for submission of Bids and the expiration of the period of Bid validity specified by the Bidder in the Bid Submission Form.</p>

The request for clarification and the response shall be in writing and no change in price or substance of the Bid shall be sought, offered or permitted.
23. Evaluation of Eligibility and Qualification	<p>In general terms, Bidders that meet the following criteria may be considered qualified:</p> <ul style="list-style-type: none"> <li>a) They are not included in IDLO Sanctions lists (EU, US, UN);</li> <li>b) They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments,</li> <li>c) They have the necessary similar experience, technical expertise, production capacity where applicable, quality certifications, quality assurance procedures and other resources applicable to the provision of the services required;</li> <li>d) They are able to comply fully with IDLO General Terms and Conditions of Contract and IDLO Supplier Code of Conduct;</li> <li>e) They do not have a consistent history of court/arbitral award decisions against the Bidder; and</li> </ul>

	f) They have a record of timely and satisfactory performance with their clients.
24. Price variation	Bidders shall not vary their prices for any reason after the deadline of the tender and while the Bid is still valid.
25. Preliminary Screening	IDLO will screen the Bids' Annex D and E to determine whether they are complete, whether the documents have been properly signed, and whether the Bid is generally in order.
26. Correction of errors	In the event of a discrepancy between the unit price and the total price, the unit price shall prevail and the total price shall be corrected by IDLO. If the Bidder does not accept the final price based on IDLO's correction of errors, its Bid will be rejected.
27. Due Diligence	<p>IDLO reserves the right to undertake a due diligence exercise aimed at determining to its satisfaction, the validity of the information provided by the Bidder. 33. Debriefing	In the event that a Bidder is unsuccessful, the Bidder may request a debriefing from IDLO. The purpose of the debriefing is to discuss the strengths and weaknesses of the Bidder's submission, in order to assist the Bidder in improving its future bids for IDLO procurement opportunities. The content of other bids and how they compare to the Bidder's submission will not be discussed.
34. Payment Terms	IDLO will make payment within <b>30 days</b> after satisfactory receipt of all goods and upon submission of the invoice by the Supplier.
35. General Terms and Conditions and Supplier Code of Conduct	Any Contract that will be signed as a result of this ITB shall be subject to the IDLO's General Terms and Conditions and Supplier Code of Conduct attached as Annex H. ## ANNEX C

### TERMS OF REFERENCE / TECHNICAL SPECIFICATIONS HOTEL ACCOMMODATION and CONFERENCE SERVICES

#### 1. INTRODUCTION

In order to achieve cost efficiency from economies of scale whilst ensuring outstanding quality of service, IDLO Indonesia is looking to establish multiple Framework Agreements with potential Hotels to serve all its accommodation and conference services requirements. A Framework Agreement is a type of agreement with its terms and conditions under which procurement of goods or services can be affected over a specified period, but which places no obligation on IDLO to order any minimum or maximum quantity.

The Framework Agreement will have its specified list of services, indicating the upper ceiling price agreed at the ITB stage. The upper ceiling price list (as well as discounted rates, if applicable) are provisional and are intended solely for the purposes of evaluation and comparison of Bids and to determine the upper ceiling limit in the Framework Agreement.

The duration for Framework Agreement(s) is 12 months with an option to extend at the same price, terms and conditions for a second 12-month period subject to satisfactory performance and agreement by both parties.

#### 2. PURPOSE OF THIS TENDER

IDLO issues this ITB for the purpose of soliciting bids from service providers for provision of Hotel Accommodation and Conference Facilities Services as per the schedule below in the 4 Star and 5 Star range (according to international hotel/accommodation criteria) for IDLOs Meetings, Conferences, Trainings and other Events between 2023 and 2024 **throughout Indonesia**, particularly in **Bali, Bandung, Banten, Jakarta, Makassar, Palembang, and Yogyakarta**.

#### 3. REQUIREMENT

##### 3.1 Specific Requirement

In this respect, the specific requirement from IDLO covers:

- i. Hotel Accommodation
- ii. Meetings, Conferences, Workshop, Trainings and other Events Venue and Catering Services (Meeting Package)
- iii. Shuttle/Transfer services for out-of-town participants from airport to hotel round trip (optional)

##### 3.2 The Minimum Requirement for Hotel Accommodation

###### 3.2.1 Type A – Accommodation only

- a) For IDLO Employees, Interns, Consultants, Beneficiaries or Attendees to IDLO Trainings on short visits and may stay for a minimum of one (1) night
- b) Single/double/extra bedroom on a Bed and Breakfast basis with Internet access (internet cable or Wi-Fi) in the room (included in the per night price).
- c) Late Check in/Check out subject to availability.

- d) Extra services requested directly by any IDLO Employee, Interns, Consultants, Beneficiaries or Attendees to IDLO Trainings for his/her personal use will be paid directly by the person. IDLO is not responsible to settle any invoices for personal use.

### 3.2.2 Type B – Accommodation with Meetings, Conferences, Trainings and other Events

- a) Single/double/extra bedroom on a Bed and Breakfast basis with Internet access (internet cable or Wi-Fi) in the room (included in the per night price)
- b) Booking for accommodation with Meeting Conferences, Trainings, and Other Events include Lunch and/or Dinner services subject to IDLO request.
- c) Late Check in/Check out subject to availability
- d) Free parking for participants
- e) The number of rooms may not always commensurate with the number of event participants.
- f) Any additional expenses like telephone, minibar, or extra days including upgrade of accommodation will be considered as personal expenses and shall be covered directly by the person.
- g) Extra services requested directly by any IDLO Employee, Interns, Consultants, Beneficiaries or Attendees to IDLO Trainings for his/her personal use will be paid directly by the person. IDLO is not responsible to settle any invoices for personal use.

### 3.3 The Minimum Requirement for Meetings, Conferences, Trainings and other Events

- a) LCD projector per room per day including: Screen, Remote Control, and minimum of 1 speaker for Small-Sized Conference Rooms
- b) Wireless microphones; two for Small and Medium-Sized Conference Rooms (fits up to 50 people) and four for Large Conference rooms (over 50 people)
- c) A minimum of 1 Flipchart per Conference Room per day with block of Recycled Paper and a set of Markers for each Flipchart
- d) A minimum of 1 White Board per Conference Room per day with set of markers and eraser for each
- e) Internet connectivity link with minimum speed of 32 MB
- f) Free Wi-Fi Internet Connection for all participants
- g) A minimum of 3 Universal Power Adapters per Conference Room per day
- h) Pens and Notepads for each participant placed on table on first day
- i) Mineral Water 1 litre per day placed between two chairs in the Conference Room in glass containers

### 3.4 The Minimum Requirement for Catering Services

#### a. Coffee Breaks

- Instant Coffee, Brewed Coffee, Tea, Milk, Lactose Free Milk, Sugar and Sugar Substitute/Artificial Sweetener, Mineral Water
- Two types of biscuits, minimum of two types of snacks and two types of fruits

#### b. Lunch and/or Dinner – Three Course Meal

- Appetizer
  - ✓ Soup and Salad as appropriate, suitable for Vegetarians
  - ✓ Fresh bread rolls

- Main Course
  - ✓ Meat Dish (Beef, Lamb or Chicken), Fish/Seafood
  - ✓ Varieties of vegetables
- Desserts
  - ✓ Fresh fruits
  - ✓ Sliced Cakes
- Choices of Juice, Soft drinks, Mineral Water
- Coffee, Tea, Milk, Lactose Free Milk, Sugar and Sugar Substitute/Artificial Sweetener

### **3.5 The Minimum Requirement for Shuttle/Transfer services for out-of-town participants**

- IDLO shall provide details 24 hours prior to requirement
- The driver must have the required permits/licenses to carry passengers
- Vehicles must be fully insured and road worthy and registered for carrying passengers
- All passengers must be insured with third party liability coverage

## **4. CONDITION OF THE FRAMEWORK AGREEMENT(S)**

- a. This ITB is expected to result in Framework Agreement(s) with one or several successful Service Providers.
- b. A Framework Agreement is a type of agreement with its terms and conditions under which procurement of goods or services can be effected over a specified period, but which places no obligation on IDLO to order any minimum or maximum quantity. All terms and conditions including the prices will remain unchanged during the period of the Framework Agreement(s).
- c. The Framework Agreement will be signed for a period of up to 12 months with the possibility of another 12 months extension subject to satisfactory performance, funding and agreement by both parties by amending the Framework Agreement. The overall duration of the Framework Agreement shall not exceed 24 months.
- d. Each Framework Agreement will have its specified list of services, indicating the upper ceiling price agreed at the ITB stage. The upper ceiling price list (as well as discounted rates, if applicable) are provisional and are intended solely for the purposes of evaluation and comparison of Bids and to determine the upper ceiling limit in the Framework Agreement. The Service Providers cannot go beyond the upper ceiling price.
- e. After entering into a Framework Agreement, IDLO shall place bookings on a “need basis”.
- f. IDLO shall initiate a Secondary Tender to request confirmation from the Service Provider on its availability and prices on the required dates/days by email. The Service Provider shall confirm by return email within 48 hours (including any applicable discounts).
- g. IDLO shall make award decision based on “lowest priced, most technically acceptable/compliant offer”.

- h. The confirmed award shall be in the form of a duly authorized Work Order. The Work Order shall include the number/s of persons/participants, services required, and corresponding amounts shall be indicated for the specific booking / event in each case. Bookings are made with specific venues and may not be transferrable or sub-contracted to other venue.
  - i. By signing the Work Order, the Service Provider is confirming that IDLO may modify the number of participants within  $\pm 20\%$  tolerance and that there is a **Free** Cancellation Policy at the maximum of one day prior the event.
  - j. The Service Provider shall returned the sign copy of the Work Order within 24 hours of receipt by email.
  - k. IDLO will review the quality of services and deliverables prior to the end of the first 12 months of the agreement. Subject to satisfactory performance and agreement by both parties, a 12-month extension may be agreed to at the same upper ceiling price, terms and conditions. The maximum overall duration of the Framework Agreement will not exceed 24 months. The upper ceiling price will remain unchanged during the period of Framework Agreement.
  - l. IDLO is seeking bids by Lots. Hotel Accommodation and Conference Facilities Services Providers may bid for all or selected lots however the minimum requirements per lot must be fully met.
