The Bidders shall be invited to confirm the extension in writing, without any modification whatsoever on the Bid. The Bidders may choose not to extend the validity period of the Bid upon request of IDLO.
16. ## ANNEX C TERMS OF REFERENCE / TECHNICAL SPECIFICATIONS

### A. About IDLO

The International Development Law Organization (IDLO) is an intergovernmental organization exclusively devoted to promoting the rule of law. Established in 1983, IDLO works to enable governments and empower people to reform laws and strengthen institutions to promote peace, justice, sustainable development and economic opportunity. Its programs, research and policy advocacy cover the spectrum of rule of law from peace and institution building to social development and economic recovery in countries emerging from conflict and striving towards democracy.

The Assembly of Parties is IDLO's highest decision-making body. It is composed of Representatives of all Member Parties, which have joined the Establishment Agreement of IDLO. IDLO currently has 37 Member Parties.

IDLO has its Headquarters in Rome, a Branch Office in The Hague, Liaison Offices for the United Nations in New York and Geneva, and Country Offices in Afghanistan, Armenia, the Bahamas, Burkina Faso, Honduras, Indonesia, Kenya, Kyrgyzstan, Jordan, Liberia, Mali, Mexico, Moldova, Mongolia, Myanmar, Niger, the Philippines, Somalia, Tunisia, Uganda and Ukraine.

The work of IDLO is sustained by a dynamic, diverse, multinational and multicultural workforce, comprised of over 400 employees plus additional personnel in the non-employee category such as consultants and interns. About one fourth of the IDLO workforce is based in its Headquarters in Rome, while the rest are spread across the globe in our Branch and Country offices.

### B. Background

IDLO's Financial Reporting Center (FRC) Program, is implementing a project that aims to build a soundly regulated financial sector in Somaliland that can operate in a professional manner consistent with international standards. To this end, IDLO will assist the FRC to establish a clear identity and standard operating procedures, and will strengthen the operational capacity of the FRC through on-the-job mentorship and specially designed training programs. Finally, IDLO will strengthen the collaboration between the FRC, the police and the Office of the Attorney General around the investigation and prosecution of serious financial crimes and its supporting the Bank of Somaliland (hereinafter the "the Bank") which was established in 1994 with the mandate of ensuring financial stability and oversight of financial institutions. While the Somaliland Government has made substantial progress on establishing a sound legal and regulatory framework, however, the Bank continues to face significant capacity limitations which impede its ability to provide the necessary support and supervisory functions. One particular area is the Bank's ability to combat money laundering and terrorist financing. Somaliland's Anti-Money Laundering Law No. 87/2019, approved in December 2019, formally established the Financial Intelligence Unit of Somaliland (FIU) as an independent department of the Bank responsible for receiving, requesting, analyzing, and appropriately disseminating information concerning money laundering and terrorist financing. As a new department, the FIU faces several internal and external challenges that impede its work. Some of the key external challenges include limited financial sector and public understanding and awareness of the anti-money laundering law and its obligations including why customers have to disclose additional personal information and how the

government uses this information in its AML/CFT efforts. Creating public support through public education and awareness-raising on AML/ CFT issues is therefore crucial to preventing and combating money laundering and terrorist financing.

### **C. Condition of Contract and Expected Output**

IDLO is looking for a Media Service Provider to design the following media products for dissemination by the Bank of Somaliland:

The Contractor will be responsible for the following deliverables and activities:

#### **1. Lot 1 – Animated Video Production:**

- Production of a 2-minute animated video for airing on national TV and FIU Department website.
- Animated video must be in 3D style, 2 minutes in duration with Somali voice over and subtitles in English and in full HD (1920 x 1080 (1080p)
- IDLO will provide the message for the animated video and the Contractor is required to prepare a script and produce the video which will focus on the requirements of the Somaliland Anti-Money Laundering Law.
- The scenario will be written by the Contractor and will be approved by IDLO and by the FIU Department of the Bank of Somaliland.
- The final versions of the video will be approved by IDLO and by the FIU Department of the Bank of Somaliland.

#### **2. Lot 2 - Pamphlet Design**

- Conceptualize, design and develop a 4-page pamphlet intended for reporting entities and other external stakeholders of the Bank of Somaliland.
- The pamphlet will capture among other things relevant information about the Somaliland Anti-Money Laundering Law, the role and mandate of the FIU Department as well as the obligations of reporting entities.
- The materials for the pamphlet will be provided by IDLO to the Contractor.
- The pamphlet design should be submitted in a format ready for printing.

#### **3. Lot 3 – Billboard Poster Design**

- Design 3 meters by 6 meters billboard poster communicating a 400-character message on Know Your Customer requirements to the public.
- The billboard design should be submitted in a format ready for printing.

#### **4. Lot 4 - Sticker Poster Design**

- Design a sticker poster communicating a 350-character message on Know Your Customer requirements;
- Size: A4

The Company will report to the IDLO Senior program Manager Country Director and will be requested to work in close coordination with the Head of Bank of Somaliland.
