## ANNEX C TERMS OF REFERENCE / TECHNICAL SPECIFICATIONS VEHICLE MAINTENANCE SERVICES

#### A. About IDLO

The International Development Law Organization (IDLO) is an intergovernmental organization exclusively devoted to promoting the rule of law. Established in 1983, IDLO works to enable governments and empower people to reform laws and strengthen institutions to promote peace, justice, sustainable development and economic opportunity. Its programs, research and policy advocacy cover the spectrum of rule of law from peace and institution building to social development and economic recovery in countries emerging from conflict and striving towards democracy.

The Assembly of Parties is IDLO's highest decision-making body. It is composed of Representatives of all Member Parties, which have joined the Establishment Agreement of IDLO. IDLO currently has 37 Member Parties.

IDLO has its Headquarters in Rome, a Branch Office in The Hague, Liaison Offices for the United Nations in New York and Geneva, and Country Offices in Afghanistan, Armenia, the Bahamas, Burkina Faso, Honduras, Indonesia, Kenya, Kyrgyzstan, Jordan, Liberia, Mali, Mexico, Moldova, Mongolia, Myanmar, Niger, the Philippines, Somalia, Tunisia, Uganda and Ukraine.

The work of IDLO is sustained by a dynamic, diverse, multinational and multicultural workforce, comprised of over 400 employees plus additional personnel in the non-employee category such as consultants and interns. About one fourth of the IDLO workforce is based in its Headquarters in Rome, while the rest are spread across the globe in our Branch and Country offices.

#### B. Background

IDLO aims to perform this support efficiently, effectively with accountability and transparency, and as such, the IDLO office in Afghanistan is setting up long-term agreements for various operational functions that could contribute to increased cost-effectiveness for the program implementation.

Vehicle Maintenance is one of the back-office services required to keep IDLO operations running effectively and for this purpose, IDLO Afghanistan office is setting up a long-term agreement to ensure that IDLO vehicle fleet is in good condition and run in a cost-effective way to efficiently deliver program activities.

#### C. Condition of Contract and Expected Output

IDLO is looking to establish one or several Framework Agreement(s) with able and qualified Suppliers. A Framework Agreement is a type of agreement with its terms and conditions under which procurement of goods or services can be effected over a specified period, but which places no obligation on IDLO to order any minimum or maximum quantity. All terms and conditions including the prices will remain unchanged during the period of the Framework Agreement(s).

After entering into a Framework Agreement, IDLO shall place order on a "need basis".



The confirmed award shall be in the form of a duly authorized Work Order. The Work Order is IDLO's commitment against Framework Agreements. The Work Order will provide information on the exact items, its quantities and unit prices (lifted from the Framework Agreement) in addition to other logistic details.

The duration for Framework Agreement(s) is 12 months with an option to extend at the same price, terms and conditions for a second 12-month period subject to satisfactory performance and agreement by both parties.

## **D.** General Provisions

The maintenance and repair tasks are to be carried out in Kabul, Afghanistan. The vehicles will be delivered to the workshop and collected from the same delivery location. Where any maintenance operation is not conducted at the delivery/collection location the contractor will be responsible for any transportation services required.

## E. Qualifications of Successful Contractor

The workshop must provide qualified specialists in vehicle computer, electronic, alarm and electrical systems, fuel systems of diesel engines (including injection and turbo diesel engines), vehicle clutch, transmission and suspension, hydraulic power steering, brakes (including ABS systems), air-conditioning and heating systems, metal sheet work and painting.



## 1) Facilities to be provided by the Contractor at each location

- a. Capacity to lift whole vehicle,
- b. Sufficient capacity to manage timely repairs to applicable vehicles per lot.
- c. Tyre repair and replacement
- d. Run-flat system repair and replacement
- e. Experience with servicing 4x4 vehicles

- g. Secure parking space
- h. Vehicle recovery capacity
- i. Engineering/fabrication capability for ancillary vehicle devices
- j. Bodywork repair and painting facilities
- k. Parts inventory, storage and management facilities
- I. Telephone, computer and internet facilities
- m. English speaking contact
- n. Ability to cooperate with the warranty provider
- o. Ability to provide Tax free invoices (in English)
- p. Priority treatment of IDLO vehicles

## 2) Equipment

- a. Electronic diagnostic and repair equipment for all vehicles specified in the contract.
- b. Special tools and test equipment for all vehicles specified in the contract.

#### 3) Requirements for stock of spare parts

The workshop must possess an initial stock of spare parts to be able to provide immediate maintenance of vehicles. A stock of spare parts must include all the parts, lubricants and accessories as necessary for the maintenance and repair of the types of vehicles specified in the contract.

Special attention will be paid to the parts origin:

- For maintenance of oil systems and engine (oil filters, gaskets of the valves cover, oil pressure indicator, taps, belts, power steering belts)
- For maintenance of air and fuel system (air and fuel filters, fuel pipes, fuel pumps)
- For repair of coolant system (coolant hoses, water pumps)
- For maintenance and repair of brake system (brake pads, brake main and working cylinders, brake fluid)
- For maintenance and repair of ignition and electronic/electrical systems
- For maintenance and repair of transmission and suspension (sealing of engine, gear box, distribution box, cross piece, shock absorbers, all rubber parts of suspension, support)
- For recovering vehicle exteriors and body works (glasses, mirrors, door locks)
- Terms of parts delivery must be as low as possible.

The Contractor must comply with all existing laws, regulations and any others that may come into force, such as:

- a. Traffic Regulation
- b. Anti-Pollution Regulation
- c. Registrar of Vehicle Regulation
- d. Factories Act

- g. Any future Regulation, By-Laws Act.

#### F. Expected Performance

The following aims at highlighting in sequential order the course of events for the performance of the ancillary services (maintenance, repair of vehicles etc.; it is based on the respective clauses of the special conditions of the contract, which prevail in case of ambiguity or divergence.

- **a.** The servicing schedule will be in accordance with the vehicle manufacturer's recommendations and any changes or alterations as defined by IDLO.
- b. IDLO will make available, at a pre-booked time and date to the contractor any vehicle that is due to have scheduled maintenance or servicing. IDLO will endeavor to make the vehicles available for scheduled maintenance and servicing at staggered intervals to avoid overbooking.
- c. The contractor will be notified with an emailed service order by IDLO Logistics section when a vehicle is due for maintenance or repair. IDLO will deliver and collect vehicles as necessary to the contractors' premises as designated in each location. The delivery address must be manned between 10:00 and 18:00 hours Monday to Saturday inclusive. Secure parking must be available.
- **d.** Where additional services or parts are required for completion of services the contractor will send prompt information to the IDLO Logistics Officer with an estimation of the parts and labour required. The quotation will be sent to IDLO for approval in advance of any repair taking place.
- e. The Contractor will arrange all parts needed to be delivered to their premises.
- **f.** Repairs will be completed in the shortest possible time using, where available, parts that are held in stock by the contractor.
- **g.** Basic Scheduled service:
  - 1. Areas to be checked during a basic scheduled service (provisional list):
  - 2. All Oils and Fluids
  - 3. All Filters
  - 4. Electrical System
  - 5. Brakes
  - 6. Steering Suspension
  - 7. Transmission
  - 8. Full inspection of the chassis, body and safety features of the vehicle must be incorporated into each scheduled maintenance.
- h. The vehicle will be collected by IDLO upon completion of services.



- i. For all lots the number of hours of labour shall be calculated using the Manufacturer's Flat Rate Schedule whenever the Manufacturer's Flat Rate Schedule is still available. These schedules must be attached to the offer.
- j. All invoicing must be presented to the Logistics Officer detailing parts and labour as proof that this work has been carried out. These must include original and copy and by vehicle number
- k. The Contractor shall warrant that the supplies are new, unused, of the most recent models and incorporate all recent improvements in design and materials. The Contractor shall further warrant that none of the supplies have any defect arising from design, materials or workmanship. This warranty shall remain valid for 1 year after provisional acceptance.


## 4. Specifications on Emergency Breakdown and Towing Services (EBTS)

- ii. The Contractor shall provide Emergency Breakdown and Towing Services (EBTS) on 24-hours basis. All towing charges shall be borne by the contractor. The service shall be rendered within the two (2) hour time period after notification of breakdown.
- iii. The Contractor has to provide an appropriate breakdown recovery vehicle to operate breakdown vehicle.
- iv. All existing vehicles with their specific brand, model and quantity are listed in AnnexA. The fleet of vehicles shall be of the following categories:
  - a. Landcruiser
  - b. Van
  - c. All old or new registered vehicles acquired by the IDLO from time to time.

## H. Service Provider Obligations:

The service provider shall submit monthly statements to IDLO. The statement shall identify all maintenance services provided by invoice number and vehicle number.

- 1. Delivery time of completed work to be communicated at time of accepting vehicle.
- 2. The contractor shall take full responsibility for any error made through maintenance rendered by it and shall be responsible at his own cost for any loss or damage.
- 3. The Contractor shall maintain an adequate inventory of officially authorized manufacturer parts for the above models of vehicles and shall have a satisfactory source of supply for such parts as may be needed in the performance of the services.
- 4. The Contractor will avail the services of his workshop and give priority to provide IDLO vehicles with all necessary repair and maintenance to comply with the service delivery timeframes above.
- 5. The Contractor shall perform all services in a diligent, skillful and professional manner in a strict compliance with the provision of this TOR and the instruction of the IDLO.
- 6. The Contractor shall keep and maintain up to-date records of all services rendered to the IDLO's vehicles and shall remind the IDLO in two weeks in advance of the next service schedule.
- 7. The Contractor shall ensure that the mechanics for any repair works are skilled (trained and certified) and sufficiently trained in the respective vehicles. Unskilled mechanics/staff shall not carry out any major repairs on IDLO vehicles.
- 8. The Contractor agrees to provide services maintenance and inspections of IDLO vehicles on Contractor's territory as agreed with IDLO.



9. The Contractor shall have land line and mobile phone access, email address and fax for continuous communication in case of emergency or unplanned replacement of parts of IDLO vehicles during the working period (from Sunday to Thursday, 08am to 05pm). All the information on services performed by the Contractor is to be provided to IDLO on monthly basis. The form and content of such information shall be agreed in advance with IDLO.

## I. Billing and Payment Procedures:

Billing procedure shall be in accordance with the following:

- 1. IDLO authorized representative shall issue a work order to the Contractor, specifying the plate number of the vehicle and requesting service/maintenance to be provided. Any additional works/services not provided in the work order shall be approved prior the works/services take place. IDLO shall not be obligated to compensate for services which were not approved in advance. (No work order to be accepted verbally.)
- 2. IDLO shall receive an invoice against services requested, which would clearly identify the maintenance services/repairs performed once the services are completed. It will also state any future issues which may arise with the vehicle and how to prevent their consequences, if necessary.
- 3. At any time, IDLO can request that replaced parts be sent at the Contractor's expense to the IDLO for inspection.
- 4. The Contractor shall maintain account for IDLO and IDLO will be responsible for the payments of its bills.
- 5. For unscheduled services/repairs, IDLO will obtain quotations, which need to be explicitly accepted by purchase order or order confirmation.
- 6. The Contractor's authorized representative shall sign/stamp Service Completion Note and send invoices to IDLO on monthly basis.
- 7. The invoices should display unique identification number, Contract number, order number, and vehicle plate number.
- 8. Monthly consolidated invoices to show outstanding amounts must be sent.

## J. Damage to IDLO's Property and Vehicles

- 1. During the execution of the contract, the Contractor shall protect all property and vehicles belonging to the IDLO left under his custody from damage or loss.
- 2. Any damage or loss of properties and vehicles belonging to the IDLO, as a result of the carelessness, negligence or otherwise of the Contractor's workmen, shall be made good or replaced by the Contractor to the entire satisfaction of the IDLO.
- 3. Should the Contractor fail to make good the damage or loss within the period specified, IDLO shall, without further reference to the Contractor, have the damage repaired or loss replaced, and all expenses incurred shall be deducted by the IDLO from the payment due to the Contractor
