**Clarifications Letter No. 1 and Amedment to ITB N\_55\_2023\_HQ**

Reference is made to IDLO ITB N\_55\_2023\_HQ issued on January 24, 2023 for Microsoft Azure Subscription Services Token:

Please find hereunder the query received and IDLO's response to it.

**1. Question 1:**

We are not able to provide the Microsoft Open License Program as it has been discontinued and is no longer available. Microsoft recommends Open Value Subscriptions as a similar current alternative".

**IDLO Reply:**

IDLO can sign an Open Value Agreement (active for 3 years, payable upfront and SA included) with a Microsoft reseller for "Azure Subscription Services Open" that provides Online Services Activation (OSA key) to be activated and loaded in IDLO "Azure in Open" subscription as prepayment credits.

**2. Question 2:**

Microsoft has retired the MOLP program, so this sku is no longer available for purchase.

The "replacement" is a migration the OPEN VALUE Program, which is a 3 year purchase commitment—payable either upfront or over 3 years.

The other alternative is to purchase it through the cloud solution program through a reseller such as ourselves, but it requires a U.S.-based tenant.

**IDLO Reply:**

As above for the Open Value Agreement that IDLO can sign with a Microsoft reseller.
