1. About IDLO



4. Condition of the Framework Agreement(s)

- A. This ITB is expected to result in Framework Agreement(s) with one or several successful Service Providers.
- B. A Framework Agreement is a type of agreement with its terms and conditions under which procurement of goods or services can be effected over a specified period, but which places no obligation on IDLO to order any minimum or maximum quantity. 
