Prof Patricia Kameri-Mbote University of Nairobi

Patricia Kameri-Mbote is a Professor of Law and Dean of the School of Law, University of Nairobi. She is a Senior Counsel and has been an Advocate of the High Court of Kenya for over 25 years. She has been engaged in the legal academy in teaching and research for over 25 years at various universities around the world in Kenya, South Africa, United States and Zimbabwe. She led the planning, initiation, launch and implementation of Strathmore Law School from 2009 to 2012 and has served as a Scholar at the Woodrow Wilson International Center for Scholars in 2006. She holds a Bachelor of Laws (LLB) from University of Nairobi, Master of Laws LLM) from University of Warwick as well as Master of Juridical Sciences (MJS) and Juridical Science Doctorate (JSD) from Stanford University. Her interests are in human rights, gender equality, social justice, land reform, environmental law, intellectual property and legal scholarship. She has written and published widely in these areas. Her recent publication is *Breaking the Mould: Lessons for Implementing Community Land Rights in Kenya* (Strathmore University Press 2016).

Asst Prof Deng Awur Wenyin University of Juba

Deng Awur Wenyin is an Assistant Professor and Head of the Department of Public Law at the College of Law, University of Juba. He is the founding-Dean of the College of Law while the University of Juba was still situated in Khartoum, The Sudan. He holds the Bachelor of Laws (LLB) of University of Khartoum and Master of Laws (LLM) of University of Leicester. He also holds the Post-Graduate Diploma in Law (PDGL) and Post-Graduate Diploma in Education (PGDE) from University of Darees-Salaam. He has a Certificate of Attendance of the All African Course in International Humanitarian Law at Centre for Human Rights, University of Pretoria. He has held several administrative positions at the University of Juba, including the Deanship of Students. He has served as a member on numerous national and constitutional bodies, including the Southern Sudan Referendum Commission, Judicial Service Commission, South Sudan Law Review (Reform) Commission, the Special Commission on the Rights of Non-Muslims in the National Capital, South Sudan Bar Association and Bahr al Ghazal University Council.

Prof Ali Suleiman Fadlalla University of Khartoum

Ali Suleiman Fadlalla is an Associate Professor and former Dean at the Faculty of Law, University of Khartoum. He has been engaged in teaching law for over 40 years—from 1974-78, at the Faculty of Law, Institute of Administration, Ahmadu Bello University-Zaria, Nigeria and since 1978, except for a few years spent outside The Sudan, at the Faculty of Law, University of Khartoum. He has been a Fulbright Scholar at the Fletcher School of Law & Diplomacy (1992-95) and a Fellow at the Human Rights Program, Harvard Law School (1993) and the Center for International Scholars, MIT (1994-95). From 1995-2003, he worked with the United Nations Mission for Referendum in the Western Sahara (MINURSO). He holds the Bachelor of Laws (LLB) from University of Khartoum, Master of

Laws (LLM) from University of Birmingham and Doctor of Philosophy (PhD) from University of London. He has published on constitutional law, human rights and the legal system in Sudan.

El-Faki Chol Lual University of Juba

El-Faki Chol Lual is the Dean of the College of Law, University of Juba. He is an advocate, consultant and commissioner for oaths. He has served as Deputy Dean and Head of the Department of Public Law at the College of Law. As a lecturer at the College of Law, he teaches, among others, the courses on Constitutional Law and Constitutional Development in South Sudan. He holds the Bachelor of Laws (LLB) and Master of Laws (LLM) of University of Khartoum. He is currently pursuing a PhD degree at the University of Khartoum, researching on 'The Constitutional and Legal Aspects of Freedom of Association in South Sudan'. Prior to the independence of South Sudan, he began his academic career as a Teaching Assistant at the Faculty of Law, University of Khartoum. He is a member of several constitutional bodies in South Sudan, including the Judicial Service Commission, South Sudan Law Review Commission and the National Constitutional Review Commission.

Taban Kitson South Sudan Law Society

Taban Kiston is a South Sudanese lawyer with expertise in human rights, international criminal law and transitional justice. He has worked with the South Sudan Law Society as Programs Coordinator and supervised various projects including a Human Rights Defenders Initiative, Access to Justice, Civil Society engagement with governmental policy formulation process on Constitution and Governance programs. He was chairperson of the Civil Society Forum for Human Rights (CSFHR) in South Sudan. He assisted civil society organizations in South Sudan submit the first shadow report of Universal Periodic report to OHCHR at the UN universal periodic session held in Geneva in 2011. He holds the Bachelor of Laws (LLB) from Cavendish University Uganda and the Master of Laws (LLM) in International Human Rights and Humanitarian Law from University of Essex. He is an alumnus of the OSF Civil Society Leadership Award.

Lindi Coetzee

Nelson Mandela Metropolitan University

Lindi Coetzee is a senior lecturer at the Law faculty of the Nelson Mandela Metropolitan University. She holds the degrees of B Juris, LLB, LLM and is an advocate of the High Court. She is the national director of Street Law (a non-profit company that specialises in presenting participatory legal- human rights and democracy education to the general public). She established the Street Law NMMU outreach program. She was the chairperson of the Learning Area Committee for Human and Social Sciences in Port Elizabeth's Western Region. Lindi represented the Human Rights Commission on National Standards Body 09 for Health Sciences and Social Services. She has published numerous research outputs and research manuals on corporate law, insolvency law and human rights and has delivered conference papers at both national and international conferences.

Majok Mayen Anyang PACT South Sudan

Majok Mayen Anyang is the Satellite Legal Aid Clinic Manager for the clinic established by PACT South Sudan at the Juba Civic Engagement Centre (and affiliated with the College of Law, University of Juba to provide experiential learning opportunities to law students). He has worked as the legal aid clinic manager/coordinator in Kuajok Warrap State in South Sudan. He is a licenced advocate after previously working with the renowned law firm of Dr W.K. Bior & Co. Global Legal Services as an advocate trainee. From 2006 to 2008, he worked with the Directorate of Contracts, Ministry of Justice. He holds a Bachelor of Laws (LLB) from Kampala International University (KIU). His interests are in areas of community service, legal aid and access justice for the vulnerable.

Kuyang Harriet Logo Mulukwat University of Juba

Kuyang Harriet Logo Mulukwat is a consultant in the area of democratic governance, access to justice and the rule of law for UNDP, UNWOMEN, IGAD and international NGOs. She is also a part-time

She has published academic papers on common law and statutory law, gender and justice, and conflict in South Sudan. Rea Abada Chiongson Senior Gender Specialist IDLO

Rea Abada Chiongson is Senior Gender Advisor for the International Development Law Organization (IDLO) and, in that capacity, she leads the organization's work on gender and the rule of law. She is a lawyer with more than 20 years of experience on gender, law, justice and development issues. Prior to IDLO, she worked at the World Bank in Washington DC for 4 years as the Gender Advisor for its Gender, Conflict and Fragility Program of the World Bank Institute and as the Gender and Justice Advisor of its Justice Reform Practice Group (Justice Anchor) under the Legal Vice-Presidency. Her work includes providing technical support in developing legal frameworks and mechanisms for the advancement of gender equality; integrating gender and justice concerns across sectors and thematic areas and building multi-sectoral capacity. She holds the Bachelor of Arts (BA) and Juris Doctor (JD) from Ateneo de Manila University in The Philippines and a Master of Laws (LLM) from Columbia University, where she was a Fulbright Scholar.

Prof Justice John Wuol Makec University of Juba

John Wuol Makec is the former Chief Justice of South Sudan and President of the Supreme Court of South Sudan. Prior to 2007, he has served as a Justice of the Supreme Court of The Sudan. In 2014, he was appointed Honorary Professor at the College of Law, University of Juba. Prior to the appointment, he was already teaching courses on Customary Law, Criminal Procedure, Civil Procedure and the Law of Evidence. He has served as a Course Trainer on Civil Procedure and Evidence in the procedural law training supported IDLO for the Judiciary of South Sudan. He holds the Bachelor of Laws (LLB) from University of Khartoum and a Master of Laws (LLM) from University of London. He chaired the Investigation Committee on Human Rights Abuses following the mid-December 2013 crisis. He has written extensively on customary law and legal systems and is the author of *The Customary Law of the Dinka People of Sudan: In Comparison with aspects of Western and Islamic Laws* (1988).

Dr Alphonse Muleefu University of Rwanda

Alphonse Muleefu is a Senior Lecturer at the School of Law of the University of Rwanda, and a College Director of Research, Innovation and Post-graduate Studies at the College of Arts and Social Sciences University of Rwanda. He is an External Research Fellow at INTERVICT, Tilburg University, Netherlands. He holds a Bachelor of Laws (LLB) from National University of Rwanda (as it was then) as well as Master of Laws (LLM) in Public International and European Law and Doctor of Philosophy (PhD) from Tilburg University.
