17. Validity Period of Bids	All Bids will be valid for 90 days from the deadline for submission of Bids. In exceptional circumstances IDLO may request the Bidders to extend the validity of the Bid beyond what has been initially indicated in this ITB. The Bidders shall be invited to confirm the extension in writing, without any modification whatsoever on the Bid. The Bidders may choose not to extend the validity period of the Bid upon request of IDLO.
18. Modification and withdrawal of Bids	The Bidder may modify/withdraw its Bid after the Bid's submission, provided that written notice of the withdrawal is received by IDLO prior to the deadline prescribed for submission of Bids. The Bidder's modification/withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of clause Deadline for Submission of Bids.
	No Bid may be modified nor withdrawn after the deadline for submission of Bids.



19. Amendment of the Bid	No Bid may be modified/withdrawn in the Interval between the deadline for submission of Bids and the expiration of the period of Bid validity specified by the Bidder in the Bid Submission Form. 22. Clarification of Bids	To assist in the examination, evaluation and comparison of Bids, IDLO may at its discretion ask the Bidder for clarification of its Bid. The request for clarification and the response shall be in writing and no change in price or substance of the Bid shall be sought, offered or permitted.
23. Evaluation of Eligibility and Qualification	 In general terms, Bidders that meet the following criteria may be considered qualified: a) They are not included in IDLO Sanctions lists (EU, US, UN); b) They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments, c) They have the necessary similar experience, technical expertise, production capacity where applicable, quality certifications, quality assurance procedures and other resources applicable to the provision of the services required; d) They are able to comply fully with IDLO General Terms and Conditions of Contract and IDLO Supplier Code of Conduct; e) They do not have a consistent history of court/arbitral award decisions against the Bidder; and f) They have a record of timely and satisfactory performance with their clients.
24. Price variation	Bidders shall not vary their prices for any reason after the deadline of the tender and while the Bid is still valid.

ANNEX C TERMS OF REFERENCE TEMPLATE FRAMEWORK AGREEMENT FOR HOTEL ACCOMMODATION AND CONFERENCE SERVICES

1. About IDLO

The International Development Law Organization (IDLO) is an intergovernmental organization exclusively devoted to promoting the rule of law. Established in 1983, IDLO works to enable governments and empower people to reform laws and strengthen institutions to promote peace, justice, sustainable development and economic opportunity. Its programs, research and policy advocacy cover the spectrum of rule of law from peace and institution building to social development and economic recovery in countries emerging from conflict and striving towards democracy.

The work of IDLO is sustained by a dynamic, diverse, multinational and multicultural workforce, comprised of over 400 employees plus additional personnel in the non-employee category such as consultants and interns. About one fourth of the IDLO workforce is based in its Headquarters in Rome, while the rest are spread across the globe in our Branch and Country offices.

IDLO's programmatic approach in Latin American and the Caribbean (LAC), in line with its strategic plan is especially focusing on Good Governance and transparency.

2. Purpose of this tender

IDLO issues this ITB for the purpose of soliciting bids from service providers for provision of Hotel Accommodation and Conference Services as per the schedule below in the <u>4 Star and 5</u> <u>Star range</u> (according to international hotel/accommodation criteria) for IDLOs Meetings, Conferences, Trainings and other Events between <u>1 April 2024 and 1 April 2025</u> in <u>the Commonwealth of The Bahamas.</u>

3. Requirement

A. In this respect, the specific requirement from IDLO covers:

- i. Hotel Accommodation
- ii. Conference Services
- B. The Minimum Requirement for Hotel Accommodation
 - i. Type A Accommodation only
 - a) For IDLO Employees, Interns, Consultants, Beneficiaries or Attendees to IDLO Trainings on short visits and may stay for a minimum of one (1) night
 - b) Single kingsize bedroom on a Bed and Breakfast basis with Internet access (Wi-Fi) in the room (included in the per night price)
 - c) Late Check in/Check out subject to availability
 - d) Tea/Coffee making facility with no extra charges in the rooms
 - e) Room service available upon request
 - f) Laundry service available upon request
 - g) Extra services requested directly by any IDLO Employee, Interns, Consultants, Beneficiaries or Attendees to IDLO Trainings for his/her personal use will be paid directly by the person. IDLO not be responsible to settle any invoices.



- ii. Type B Accommodation only
 - h) For participants and guests (not IDLO staff) on short visits and may stay for a minimum of one (1) night
 - i) Single bedroom on a Bed and Breakfast basis with Internet access (Wi-Fi) in the room (included in the per night price)
 - j) Late Check in/Check out subject to availability
 - k) Tea/Coffee making facility with no extra charges in the rooms
 - l) Room service available upon request
 - m) Laundry service available upon request
- C. The Minimum Requirement for Meeting room
 - i. Conference Rooms fitting up to 20 people, with Natural Day Light, equipped as follows:
 - ii. LCD projector per Conference Room per day including Screen, Remote Control, Laser Pointer and 2 Speakers
 - iii. One Laptop per Conference Room per day that can be connected for presentation
 - iv. Two wireless microphones
 - v. A minimum of 2 Flipcharts per Conference Room per day with block of Recycled Paper and a set of Markers for each Flipchart
 - vi. Internet connectivity link with minimum speed of 32 MB
 - vii. Free Wi-Fi Internet Connection for all participants
 - viii. Still or Sparkling Water 1 Litre per person per day placed on the tables in the Conference Room in glass containers (no single use plastics)
- D. The Minimum Requirement for Conference Services

Coffee break, buffet style catering including:

- a) Instant Coffee, Brewed Coffee, Tea, Milk, Lactose Free Milk, Sugar and Sugar Substitute/Artificial Sweetener, two types of juice, two types of soft drinks, Still Water
- b) Two types of snacks (pastries, muffins, mini sandwiches) and two types of fruits
- c) No single use plastic allowed

Lunch, buffet style catering including:

- d) Main meal including a vegetarian option
- e) Two types of desserts and two fresh fruits
- f) Two types of juice, two types of soft drinks, Still or Sparkling Water
- g) Instant Coffee, Brewed Coffee Tea, Milk, Lactose Free Milk, Sugar and Sugar Substitute/Artificial Sweetener

4. Condition of the Framework Agreement(s)

- A. This ITB is expected to result in Framework Agreement(s) with one or several successful Service Providers.
- B. A Framework Agreement is a type of agreement with its terms and conditions under which procurement of goods or services can be effected over a specified period, but which places no obligation on IDLO to order any minimum or maximum quantity. All terms and conditions including the prices will remain unchanged during the period of the Framework Agreement(s).



- C. The Framework Agreement will be signed for a period of up to 12 months with the possibility of another 12 months extension subject to satisfactory performance, funding and agreement by both parties by amending the Framework Agreement. The overall duration of the Framework Agreement shall not exceed 24 months.
- D. Each Framework Agreement will have its specified list of services, indicating the upper ceiling price agreed at the ITB stage. The upper ceiling price list (as well as discounted rates, if applicable) are provisional and are intended solely for the purposes of evaluation and comparison of Bids and to determine the upper ceiling limit in the Framework Agreement. The Service Providers cannot go beyond the upper ceiling price.
- E. After entering into a Framework Agreement, IDLO shall place bookings on a "need basis".
- F. IDLO shall initiate a Secondary Tender to request confirmation from the Service Provider on its availability and prices on the required dates/days by email. The Service Provider shall confirm by return email within 48 hours (including any applicable discounts).
- G. IDLO shall make award decision based on "lowest priced, most technically acceptable/compliant offer".
- H. The confirmed award shall be in the form of a duly authorized Work Order. The Work Order shall include the number/s of persons/participants, services required, and corresponding amounts shall be indicated for the specific booking / event in each case. Bookings are made with specific venues and may not be transferrable or sub-contracted to other venue.
- I. By signing the Work Order, the Service Provider is confirming that IDLO may modify the number of participants within ± 20% tolerance and that there is a Free Cancellation Policy within seven days of event.
- J. The Service Provider shall returned the sign copy of the Work Order within 24 hours of receipt by email.
- K. IDLO will review the quality of services and deliverables prior to the end of the first 12 months of the agreement. Subject to satisfactory performance and agreement by both parties, a 12-month extension may be agreed to at the same upper ceiling price, terms and conditions. The maximum overall duration of the Framework Agreement will not exceed 24 months. The upper ceiling price will remain unchanged during the period of Framework Agreement.
- L. IDLO is seeking bids by Lots. Hotel Accommodation and Conference Services Providers may bid for all or selected lots however the minimum requirements per lot must be fully met.
