1. General Considerations	In preparing the Proposal, the Bidder is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal. The Bidder will not be permitted to take advantage of any errors or omissions in the RFP. Should such errors or omissions be discovered, the Bidder must notify IDLO.
2. Cost of the Proposal	The Bidder shall bear all costs associated with the preparation and submission of the Proposal. IDLO will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the solicitation.
3. Currency of Proposals	Proposals shall be nominated exclusively in Tunisian Dinars <i>Note: Local Bidders/Suppliers must comply with any applicable laws regarding doing business in other currencies</i>
4. Language of the Proposal	The Proposal and all correspondence and documents relating to the Proposal exchanged by the Bidder and IDLO shall be written in the English language.
5. Delivery Term and Place	Services are to be provided in full by 26 June 2021 to IDLO Tunisia Country Office located at Carthage Centre, Rue du Lac 2 Eme Etage Les Berges Du Lac Tunis. Bidder to advise IDLO if their proposal has elements of supply of goods. If yes, Bidder must inform if Customs Clearance are required and whose responsibility it is to do so
6. Deadline for Submissions of Proposals	The Proposal shall be addressed to IDLO on or before Date: May 25, 2021 Time: 15:00 Hours Rome, Italy local time. <i>Note: Proposals submitted by email must be limited to a maximum of 10MB, virus-free and no more than two email transmissions. Late Proposals	<p>Any Proposal received by IDLO after the deadline for submission of Proposals, pursuant to clause <i>Deadline for the submission of Proposals</i>, will be rejected and sent back unopened or destroyed unopened if the return cannot be secured unless the Proposal was sent by email but was not properly received due to issues in IDLO mailing system.</p>
16. Validity Period of Proposals	<p>All Proposals will be valid for 90 days from the deadline for submission of Proposals. In exceptional circumstances IDLO may request the Bidders to extend the validity of the Proposal beyond what has been initially indicated in this RFP. The Bidders shall be</p>

	invited to confirm the extension in writing, without any modification whatsoever on the Proposal. The Bidders may choose not to extend the validity period of the Proposals upon request of IDLO.
17. Modification and withdrawal of Proposals	<p>The Bidder may modify/withdraw its Proposal after the Proposal's submission, provided that written notice of the withdrawal is received by IDLO prior to the deadline prescribed for submission of Proposals.</p> <p>The Bidder's modification/withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of clause Deadline for Submission of Proposals. 23. Price variation	Bidders shall not vary their prices for any reason after the deadline of the tender and while the Proposal is still valid.
24. Preliminary Screening	IDLO will screen the Proposals' Annex D and E to determine whether they are complete, whether the documents have been properly signed, and whether the Proposals are generally in order. Only Bidders that pass will proceed to Technical Evaluation
25. Correction of errors	In the event of a discrepancy between the unit price and the total price, the unit price shall prevail and the total price shall be corrected by IDLO. If the Bidder does not accept the final price based on IDLO's correction of errors, its Proposal will be rejected.
26. Due Diligence	<p>IDLO reserves the right to undertake a due diligence exercise aimed at determining to its satisfaction, the validity of the information provided by the Bidder. Evaluation of Proposal	<p>A two-stage procedure is utilised in evaluating the Proposals after Preliminary Screening has been conducted; with evaluation of the Technical Proposal being completed prior to Financial Proposal being opened and compared.</p> <p>The Financial Proposals (Price Schedules) of the overall Proposals will be opened only for submissions that passed minimum technical score of 490 points of the maximum obtainable 700 points.</p> <p>The evaluation will be conducted in accordance with the cumulative analysis method, according to which the Technical and Financial Proposals have pre-assigned weights and pre-assigned maximum number of scores:</p> <ol style="list-style-type: none"> 1. Technical Proposal -70%, - 700 points maximum, 2. Financial Proposal - 30%, - 300 points maximum. <p>The contract will be awarded to the Proposal with highest combined score obtained in technical and financial evaluation.</p> <p>Technical Evaluation</p> <p>The technical Proposal is evaluated on the basis of its responsiveness to the Terms of Reference (TOR) as per the evaluation criteria below. The obtainable number of points specified for each evaluation criterion indicates the relative significance or weight of the item in the overall evaluation process.</p> <p>Financial Evaluation</p>

	In the second stage the Financial Proposals of all Bidders who attained a minimum 490 points in Technical Evaluation will be reviewed. The lowest amount for technically qualified Financial Proposal will be awarded maximum 300 points and other Financial Proposals will be awarded points in accordance with the following formula: Financial Proposal score = (Lowest Price / Price under consideration) x 300.
29. Debriefing	In the event that a Bidder is unsuccessful, the Bidder may request a debriefing from IDLO. The purpose of the debriefing is to discuss the strengths and weaknesses of the Bidder's submission, in order to assist the Bidder in improving its future proposals for IDLO procurement opportunities. The content of other proposals and how they compare to the Bidder's submission will not be discussed.
30. TERMS OF REFERENCE
DEVELOPMENT OF MOBILE APPLICATION

About IDLO

The International Development Law Organization (IDLO) is an intergovernmental organization exclusively devoted to promoting the rule of law. Established in 1983, IDLO works to enable governments and empower people to reform laws and strengthen institutions to promote peace, justice, sustainable development and economic opportunity. Its programs, research and policy advocacy cover the spectrum of rule of law from peace and institution building to social development and economic recovery in countries emerging from conflict and striving towards democracy.

The Assembly of Parties is IDLO's highest decision-making body. It is composed of Representatives of all Member Parties, which have joined the Establishment Agreement of IDLO. IDLO currently has 37 Member Parties.

IDLO has its Headquarters in Rome, a Branch Office in The Hague, Liaison Offices for the United Nations in New York and Geneva, and Country Offices in Afghanistan, Armenia, the Bahamas, Burkina Faso, Honduras, Indonesia, Kenya, Kyrgyzstan, Jordan, Liberia, Mali, Mexico, Moldova, Mongolia, Myanmar, Niger, the Philippines, Somalia, Tunisia, Uganda and Ukraine.

The work of IDLO is sustained by a dynamic, diverse, multinational and multicultural workforce, comprised of over 400 employees plus additional personnel in the non-employee category such as consultants and interns. About one fourth of the IDLO workforce is based in its Headquarters in Rome, while the rest are spread across the globe in our Branch and Country offices.

A. BACKGROUND

The Project aims to contribute to the goal of women being able to access justice and claim their rights at the local level in Tunisia through a comprehensive and integrated approach to be piloted in two governorates.

IDLO Tunisia office foresees the establishment of a Mobile Application to highlight the crafts of local professions of 160 vulnerable women from the regions of Kef and Greater Tunis. The Beneficiaries will thus benefit from a support in order to improve and expose their products to local and international demand.

The Application with its 160 showcases will shed light on the know-how of the project's Beneficiaries and will expose them to multiple local or international Internet sites and purchasing centers. Through this Activity, IDLO will enable vulnerable women to develop and enhance their work to ensure their empowerment through digital and fair trade.

B. TERMS OF REFERENCE

1) **Modules**

This RFP is for the development of an application designed for Mobile/Tablet devices with the following Modules:

Database:

- This Module will include all beneficiary, users and application data

User Module:

- Development of a secure authentication system so that each user will have the ability to create an account and log in to track their route.
- The mobile application and web-service development must consider security and data confidentiality measures.

Artisans Discovery Module:

The Module must include a section displaying the different regions of operation with the following information:

- Descriptions
- Pictures
- Activities
- List of Beneficiaries/Artisans of each region that are in collaboration with IDLO Tunisia Country Office

For each artisan, IDLO Tunisia Country Office will provide background information, biography, personal and workspace photos, geographical position on Google MAPS (using the Google Maps API) to be able to follow the route to the workshops.

The Development must also take into consideration the current Google Maps API and ongoing upgrades to develop a solution long-term compatible.

Provisions for Basic Technical Requirements

The Contractor must ensure that:

- The Application is accessible and operational on multiple platforms (Apple, Android)
 - The data displayed on the Application is automatically updated
 - A solution for integrating the data collected from the web service backend into a Content Management System to enable IDLO staff to upload, update, tag new content and display multimedia content is developed

 - The applications interface is designed in the French language.

The Bidder will designate a Web Master who will be totally allocated to work with IDLO Tunisia staff who will provide the Data.

The management of the Application will be assigned to IDLO Tunisia Office, Ministry Of Women in Tunisia and anyone designated by the Country Manager.
