**Amendment/ Clarification No: 1**

Reference is made to IDLO ITB No. N\_114-2023/ AFG/ ITB issued on 19 December 2023 for the Procurement of Solar System, Security/ Safety Equipment, and PC through IDLO Tenders website, UNGM and local platforms (ACBAR & ACCI).

Please find hereunder the queries received and IDLO's response to them.

1. "Confirm or advise if installation is requested for all lots ?"

*Answer:*

- *As specified in the Annex F of ITB document, vendor is responsible for Transportation, Installation & testing of the delivered goods in various locations within Kabul city. This applies for Lot A & Lot B.*

2. "Please advise if this bid is open for all nationalities?"

*Answer:*

- *The ITB is open for all nationalities. The vendor is to meet qualification criteria mentioned in the ITB document.*

3. "Regarding above subject and based on the needed specs it is not possible to deliver in only 15 days , please amend the query to read 15 days FCA or 45 days DAP."

*Answer:*

*The specifications for all the goods listed in the ITB are carefully searched in local markets and identified that most of the items are available in the markets. Thus, a 15 days delivery and installation period looks good and the term DDP can not be changed.*
