# Setting the scene: Sustaining Peace, Sustainable Development: Challenges and Opportunities for the Rule of Law

Keynote address:

Fabrizio Hochschild, Assistant Secretary-General for Strategic Coordination, Executive Office of the UN Secretary-General

Through SDG 16 and its emphasis on non-discrimination, fair laws and effective institutions, the 2030 Agenda has placed the rule of law at the heart of development. SDG 16 has also served to highlight the link between access to justice and the construction of peaceful, just and inclusive societies. Building on this foundation, a new Sustaining Peace agenda is emerging that points to the prevention of conflict by addressing root causes, strengthening the rule of law and promoting inclusive, sustainable growth as necessary components of a comprehensive approach to peacebuilding.

The discussion following the keynote address will focus on the contribution that the rule of law can make in the implementation of this new international strategy for the mutual advancement of conflict prevention and sustainable development; and on challenges and opportunities for the rule of law within and across the fields of peace building, humanitarian intervention and development.

#### **SESSION 1:**

### **Building Effective and Accountable Institutions to Sustain Peace**

The SDGs recognize the importance of effective and accountable institutions for promoting peaceful, just and inclusive societies. Building strong institutions is not a simple matter of transplanting "best practices" and providing knowledge and expertise but a long-term endeavor which requires sustained investment, the prioritization of function over form and the mobilization of political will for meaningful reform.

Drawing from the experiences of countries navigating conflict and fragility, this session will examine the importance of context sensitivity, local ownership and effective change management as essential elements for the success or failure of building resilient and effective justice institutions.
